ORDER

This matter comes before the South Carolina Procurement Review Panel (Panel) pursuant to a motion by all parties to settle and dismiss this appeal.

The parties have moved to have the Chief Procurement Officer's (CPO) decision in the above protests and its underlying findings vacated but to have the remedy of the decision affirmed. The CPO consents. Accordingly, the motion is granted, and the Decision by the CPO dated February 4, 2010, numbered 2010-214, and captioned In Re: Protests of Veritec Solutions, LLC and Business Vitals, LLC is hereby vacated. However, the remedy, which cancelled the intent to award to Prism Group, LLC (Prism) and directed the matter be returned to the Information Technology Management Office of the South Carolina Budget and Control Board to proceed in accordance with the South Carolina Consolidated Procurement Code, remains in effect.

Under the terms of the parties' settlement, Prism voluntarily withdraws its appeal and its proposal in this solicitation. Prism further agrees not to protest any future action in regards to the solicitation to procure a South Carolina Mortgage Log System for the Department of Consumer Affairs. Veritec Solutions, LLC and Business Vitals, LLC also

agree to dismiss their appeals in this matter.

It appearing to the Panel that the above-referenced appeal has been settled by and between the parties, it is ordered, adjudicated and decreed that the appeal is hereby dismissed with prejudice in its entirety.¹




