DESCRIPTION OF PROJECT: Development of a prioritized, phased master facility plan for TCTC's main campus & ITC campus located in Pendleton, SC and the three County Community campuses located in Anderson, Easley and Oconee. The main campus presently consists of 13 buildings and approximately 1800 parking spaces on 56 acres of challenging topography. The current Main Campus is considered to be built-out as any new facility will require the removal of an existing one. TCTC also has an additional 32 acres of undeveloped property adjacent to the Main Campus. This property also has challenging topography and is separated from the Main Campus by a creek/wetlands which is to be included in the plan. The master plan will include the following: analysis of the current campuses and solutions to accommodate an optimal number of students for the next 10-20 yrs; computer based campus maps showing the optimal campus build-out in both 2 & 3 dimensions with the ability to virtually navigate & make changes; budget estimate for each phase including demolition, construction, utility/road relocation and parking; space need analysis based on academic master plan, enrollment scenarios and desired student life improvements; parking & public transportation plan; theoretical maximum practical campus build-out; timeline for each phase detailing design, procurement & construction.
