The expansion of the existing Employee Parking Lot will include sediment and erosion control measures, limited miscellaneous demolition, clearing and grubbing, earthwork (possibly including rock excavation), storm drainage (including an underground detention system), macadam base course, concrete curb and gutter, concrete sidewalk, asphalt pavement, pavement markings, signage, installation of landscaping and irrigation, emergency call stations, and area lighting.

The expansion of the existing National Rental Car Maintenance Facility Parking Lot will include sediment and erosion control measures, limited miscellaneous demolition, relocation of existing fence, cantilevered slide gate and guardrail, earthwork, macadam base course, asphalt pavement, pavement markings, and installation of area lighting.
