

STATEWIDE CONTRACT FOR BACKHOES, LOADERS AND MOTOR GRADERS

CONTRACT PERIOD: January 23, 2019 through January 22, 2021
(THE ABOVE DATE REFLECTS THE MAXIMUM CONTRACT PERIOD)

Below are the contracts for Backhoes, Loaders and Motor Graders. There are a total of five (5) different types of equipment (lots) and each lot was awarded three (3) separate manufacturers/vendors and contracts. The purpose of awarding to three (3) different manufactures for each lot is to provide purchase flexibility for end users.

EQUIPMENT SPECIFICATIONS

Each type of equipment has Standard Specifications that apply to all backhoes, loaders and motor graders. These “Standard Specifications” can be downloaded [here](#). In addition, each type of equipment also has its own Contract Specifications that include optional equipment and configurations that are included for the “Unit Price” listed for each manufacturer/vendor. Keep in mind that the “Unit Price” listed below for each manufacture/vendor is the price offered by each based on the Standard Specification and Contract Specifications configurations listed above. If additional options are needed or if any option is included for the Unit Price but not needed by the end user, the below “10% Rule” will govern any addition or deletion.

End users should also keep in mind that when deviating from the Standard Specifications or Contract Specifications by adding and deleting options, the lowest price may not necessarily be the vendor with the lowest “Unit Price”. When these deviations occur, obtaining quotes from all vendors in that particular lot is encouraged.

OPTIONAL FEATURES/EQUIPMENT (10% RULE)

The standard contract equipment as specified above is configured to include certain options identified by end users to be the most desired. It is also understood that the standard contract equipment may not be the best fit all applications and all end users. Therefore, each contract below contains the following clause in Section VIIB:

OPTIONAL EQUIPMENT

Options not requested herein, but which may be required by the user, will be furnished by the contractor at its cost plus no more than ten percent (10%). Options include but are not limited to: enclosed cab, 4WD,

extendable dipper, 4 in 1 bucket, quick coupler, outrigger cylinder guards. Options may be manufacturer, dealer or up-fitter installed.

In cases where items required or optional items are not available from the manufacturer, contractor may use a third-party up-fitter or items may be dealer installed. When required items are not needed or required by the using governmental unit, the price of the unit shall be reduced by the contractor's cost plus no more than 10% for each item. The State reserves the right to require third party documentation of the dealer's cost of any optional items.

DELIVERY

All deliveries shall be made and all services provided to the location specified by the Using Governmental Unit in its purchase order and delivered within the days ARO listed below for each contract.

SHIPPING / RISK OF LOSS

F.O.B. Destination. Destination is the shipping dock of the Using Governmental Units' designated receiving site, or other location, as specified herein.

At the time of delivery, it shall be the contractor's and/or shipper's responsibility to unload shipments. Deliveries on flat bed semi-trailers, drop deck semi-trailers, or flatbed trucks are preferred over deliveries in enclosed trucks or trailers.

It shall be the contractor's responsibility to carry the appropriate amount of insurance coverage for the equipment while in transport and up to the time of acceptance by the agency.

OPERATIONAL MANUALS

Unless otherwise specified, contractor shall provide one operational manual and the following for each item acquired:

1. SERVICE LITERATURE

Service literature shall include (as one set) an operator's instruction manual, illustrated repair parts manual, and shop overhaul manual. CD format is preferred (documents in .pdf format) and should be furnished when available, except for the equipment operator manual that stays with the equipment. This service literature shall be complete and cover the entire unit, to include engines and transmissions.

1.1 Performance requires in conjunction with the delivery of the first unit, two (2) complete sets of service literature in addition to the equipment operator manual.

1.2 Performance requires in conjunction with the delivery of each subsequent unit one (1) complete set of service literature in addition to the equipment operator manual.

1.3 Unrestricted, multi-user computer access to electronic service literature is acceptable in lieu of printed copies. This access shall be provided at no additional cost.

TRAINING

In conjunction with delivery of the first unit, the successful bidder shall conduct a minimum one-day school on the safety, operation, maintenance, and diagnostics of the unit by factory trained expert personnel at the using entity's facility within the state. In addition, and for each subsequent unit, the successful bidder will conduct a minimum one-day school in the location where the unit is to be assigned with the using entity's operator(s) and service personnel, after the equipment has been

delivered to the location where it is to be assigned.

TRAINING MATERIALS

In conjunction with the delivery of each unit, the successful bidder shall supply one complete set of video operator training materials (DVD format preferred). This material shall adequately cover the safe and correct operation of the equipment.

WARRANTY

Contractor must at a minimum provide the manufacturer's standard written warranty upon acceptance of product. Contractor warrants that manufacturer will honor the standard written warranty provided. The standard warranty for all equipment shall be "bumper to bumper" and include travel time and mileage for a minimum of 12 months and 1,500 hours. Extended warranties will be quoted on a case by case basis as "Optional Equipment" using the cost plus 10% rule.

When local dealers are unable to complete warranty repairs, the Contractor shall serve as the facilitator for the equipment owner to address any problems or warranty claims with the manufacturer. The Contractor shall also serve as the facilitator to address any claims with the manufacturer of any sub component installed on the equipment prior to delivery. The Contractor shall be responsible for coordinating the necessary warranty issues and repairs with manufacturer/sub-contractor.
