

STATEWIDE CONTRACT FOR COMMERCIAL GROUNDS MAINTENANCE EQUIPMENT – PHASE II SOLICITATION # 5400015056

Attachments: Items that enhance or contribute to the performance of the piece of Equipment. Examples include, but are not limited to Side Mowers or Generators.

Accessories: Items that are added to Equipment that provide user comfort or aesthetic value, but do not enhance or contribute to performance or functionality. Examples include, but are not limited to, radios, air conditioners, or canopies.

DELIVERY:

All items shall be delivered FOB Destination. The term FOB Destination shall mean delivered and unloaded onto Receiving Dock of any State agency and, when applicable, any public procurement unit within the State of South Carolina will with all charges for transportation, packaging and unloading **PREPAID** by the Contractor.

All accessories or attachments with a value of less than \$100 shall be shipped **FOB Prepaid** and added to the Invoice.

Contractors may invoice end using entities for transportation, packaging and unloading charges as a pass through cost **without** markup. Contractors must communicate any additional charge to the end using entity and the parties must mutually agree to any additional charges **prior** to order acceptance by the contractor. Contractors must include these additional charges only as a separate line item on the invoice. No additional fees of any kind shall be allowed after order acceptance by the contractor. Upon request, contractors must provide backup documentation supporting any additional charge. If backup information for an invoiced fee is not provided in a timely manner, the State or end using entity may reject said fee without payment.

All 2-Cycle equipment may be **delivered FOB Destination**, unassembled in the Manufacturer's carton to be assembled by the user/purchaser.

All 4-Cycle equipment shall be delivered **FOB Destination**, assembled, serviced, oiled and ready for immediate use.

INSTALLATION:

The installation of items such as Attachments and Accessories that need to be installed by the contractor prior to delivery may be invoiced to the end using entity as a separate line item on the invoice at **contractor cost plus no more than ten percent (10%)**.

Contractors must communicate any additional charge to the end using entity and the parties must mutually agree to any additional charges **prior** to order acceptance by the contractor. Contractors must include these additional charges only as a separate line item on the invoice. No additional fees of any kind shall be allowed after order acceptance by the contractor. Upon request, contractors must provide backup documentation supporting any additional charge. If backup information for an invoiced fee is not provided in a timely manner, the State or end using entity may reject said fee without payment.

Any fees for any other reason than transportation, packaging, unloading and installation are included in the offeror's "Percent Discount".

PURCHASING CARD:

Contractors agree to accept payment by the South Carolina Purchasing Card for no extra charge for all payments up to two thousand five hundred dollars (\$2,500.00). The purchasing card allows state agencies to make authorized purchases from a vendor without the requirement to issue a purchase order.

WARRANTY:

Contractor must provide the manufacturer's standard written warranty upon delivery of product. Contractor warrants that manufacturer will honor the standard written warranty provided.

PRICE LISTS:

If not included on the contract sheets below, price lists are available upon request from the vendor.

NOTE: List prices vary by manufacturer. Therefore, a higher percentage discount does not necessarily mean a lower net price to the State. When comparing similar pieces of equipment, purchasers should consider the list price as well as the percentage discount in order to achieve the best value for the purchase.
