

STATEWIDE CONTRACT FOR COMMERCIAL GROUNDS MAINTENANCE EQUIPMENT PHASE I INCLUDING SAFETY ITEMS

Contract Period: June 1, 2018 – May 31, 2023

INTRODUCTION:

This contract was conducted in the following manner:

- 1) Bids were accepted only directly from manufacturers or from *dealers* expressly authorized to bid and act as the sole point of contact for contract performance by a manufacturer. Therefore, the contractors listed on the pages herein are solely responsible for processing purchase orders, invoicing, and receiving payments.
- 2) Contractors are permitted to set up distribution networks to ensure quality and timely service to all areas of the state. So while the contractors listed herein serve as the sole point of contact for ordering and payment purposes, local representatives may perform other service functions such as delivery or maintenance services. Changes to the dealer/distributor networks are an administrative matter, not a contractual matter, and thus will not require express authorization of MMO or the State if changes must be made. However, dealers and distributors are held to the same performance and responsibility standards as the contractors. Should performance issues arise pertaining to a dealer/distributor acting as an agent of the contractor, the contractor is responsible for handling such issues and will act as the sole point of contact in resolving these problems.
- 3) This contract covers only equipment, attachments, and accessories. Attachments are defined as items that enhance or contribute to the functionality of the piece of equipment. Examples include side mowers or generators. Accessories are defined as items that are added to equipment that provide user comfort or aesthetic value, but do not enhance or contribute to the performance functionality. Examples include radios, air conditioners, or canopies.
- 4) Repair parts are not available for purchase pursuant to this contract, and must be purchased in accordance with your agency's procurement laws and/or policies.

Bids were sought and awarded on the basis of one single percentage discount to apply to the manufacturer's full line or series for that classification. **Manufacturers' price lists will not be published within these contract sheets, as they are subject to change at any time and would be impossible to maintain.** However, price lists are available to all users and may be obtained by requesting them directly from the contractor.

NOTE: List prices vary by manufacturer. Therefore, a higher percentage discount does not necessarily mean a lower net price to the State. When comparing similar pieces of equipment, purchasers should consider the list price as well as the percentage discount in order to achieve the best value for the purchase.

This contract covers only **Commercial Grade Equipment**. Home or residential grade equipment **cannot** be purchased pursuant to this contract.

PRICE LISTS:

Price lists are available upon request from the vendor.

DELIVERY:

All 2-Cycle equipment shall be delivered FOB Destination, unassembled in the Manufacturer's carton to be assembled by the user/purchaser.

All 4-Cycle equipment shall be delivered FOB Destination, assembled, serviced, oiled and ready for immediate use.

INSPECTION:

Inspection of equipment shall be done by the receiving agency at the time of delivery.

MAINTENANCE/OPERATIONAL INSTRUCTIONS:

The contractor(s) shall furnish one (1) paper copy of complete instructions for maintenance and operation and one (1) copy of a complete replacement parts list for each piece of equipment delivered. The contractor shall also furnish one (1) copy of the manufacturer's current price parts list. These may be furnished in electronic versions if requested by the user.

WARRANTY:

Contractor must provide the manufacturer's standard written warranty upon delivery of product. Contractor warrants that manufacturer will honor the standard written warranty provided.
