CERTIFICATE OF ANALYSIS:

When required, a Certificate of Analysis (COA) must be provided documenting the performance of an analysis of the liquid product upon each delivery. The COA must be dated, include a traceable lot number specific for the product being delivered, signed by the analyst that performed the analysis, and printed on the provider's official document. The analysis must be in units of parts per million (ppm).

SITE REQUIREMENTS:

Authorized contractor and end using entity representatives shall have access at all times to the Site unless otherwise specified by the end user. End users shall not alter, adjust or repair any Equipment installed by Contractor at the Site. Contractor shall work with end users to develop an access plan that is satisfactory to all parties. Access plan may include the distribution of keys, access codes, etc. as appropriate and determined by each end user.

Within twenty (20) days of receipt of initial order, Contractor shall perform a site survey to determine if additional end user needs exist in order to install bulk or micro-bulk tanks. Survey shall include but not limited to determining needs for fill station, piping, concrete pads, vaporizers, safety items, etc. for tank installation and setup. All additional equipment, supplies and labor needed for tank installation shall be billed to the end users as a one-time charge at **no more than cost plus fifteen percent (15%)**.
