ANALYSIS

This Invitation for Bids was issued by the South Carolina Department of Transportation (DOT) for a 60 Foot Pre-stressed Concrete Bridge, 20 Foot Pre-stressed Concrete Bridge, Barrier Rails, and, Crane Rental with an Operator for Road S-30-480 – Cleve Knight Road, at Br. of Saluda River, Laurens County. An Intent to Award to Tekna Corporation was prepared and emailed to all bidders on May 15, 2017. On June 8, 2017, DOT requested cancellation of the award to Tekna Corporation indicating that the solicitation included the wrong drawings for the barrier rail drawings for the construction of the 80 foot bridge section. The award to Tekna Corporation is cancelled, the solicitation will be resolicited in accordance with the Code and FCP's protest of the award to Tekna is moot.

DECISION

For the reasons stated above, the protest of Florence Concrete Products, Inc. is dismissed.

The Intent to Award is being based on "Optional Preferences". Florence Concrete has been bidding on bridges for SCDOT for a long time and until recently we have never seen or heard of "Optional Preferences" on a solicitation. On page 32 of the solicitation, item #2, it states preferences are Optional.

Optional means it is an option, you can choose it or you do not have to choose it. If preferences are Optional, how can bids be considered apples to apples when making an award.

On page 1 of the above referenced solicitation, it states the Award will be posted on 05/12/2017. The Intent to Award shows the Posting Date as May 15, 2017. The Intent to Award was posted in SCEIS on May 23, 2017 at 04:04:12 PM. Since this award is in excess of \$100,000.00 and there is more than one vendor, the protest period is 10 days according to Section 11-35-4210 of the S.C. Consolidated Procurement Code.

On the Intent of Award, the final Statement of Award is effective May 26, 2017. If the Intent to Award was posted on May 23, 2017, the contract cannot be effective on May 26, 2017, due to the 10 day protest period.

Tekna Corporation bid - \$132,090.00

They chose the "Optional Preferences" for item #2.

The Intent to Award shows they chose Resident Vendor Preference & South Carolina/United States Made, Manufactured or Grown Preference.

Florence Concrete Products bid - \$130,990.00

We did not chose preferences because it stated that the preferences were Optional not Mandatory for item #2.

Again, because of "Optional Preferences" on item #2, the Intent to Award is not based on apples to apples.

It should be noted that Florence Concrete Products has recently started submitting bids online in SCEIS as requested by SCDOT. We were bidding online and sending a paper copy. We stopped sending a paper copy because we felt comfortable in bidding online up until now.

STATEMENT OF RIGHT TO FURTHER ADMINISTRATIVE REVIEW

Protest Appeal Notice (Revised November 2016)

The South Carolina Procurement Code, in Section 11-35-4210, subsection 6, states:

(6) Finality of Decision. A decision pursuant to subsection (4) is final and conclusive, unless fraudulent or unless a person adversely affected by the decision requests a further administrative review by the Procurement Review Panel pursuant to Section 11-35-4410(1) within ten days of posting of the decision in accordance with subsection (5). The request for review must be directed to the appropriate chief procurement officer, who shall forward the request to the panel or to the Procurement Review Panel, and must be in writing, setting forth the reasons for disagreement with the decision of the appropriate chief procurement officer. The person also may request a hearing before the Procurement Review Panel. The appropriate chief procurement officer and an affected governmental body shall have the opportunity to participate fully in a later review or appeal, administrative or judicial.

FILE BY CLOSE OF BUSINESS: Appeals must be filed by 5:00 PM, the close of business. *Protest of Palmetto Unilect, LLC*, Case No. 2004-6 (dismissing as untimely an appeal emailed prior to 5:00 PM but not received until after 5:00 PM); *Appeal of Pee Dee Regional Transportation Services, et al.*, Case No. 2007-1 (dismissing as untimely an appeal faxed to the CPO at 6:59 PM).

FILING FEE: Pursuant to Proviso 111.1 of the 2016 General Appropriations Act, "[r]equests for administrative review before the South Carolina Procurement Review Panel shall be accompanied by a filing fee of two hundred and fifty dollars (\$250.00), payable to the SC Procurement Review Panel. The panel is authorized to charge the party requesting an administrative review under the South 11-35-4210(6), 11-35-4220(5), Carolina Code 11-35-4230(6) 4410...Withdrawal of an appeal will result in the filing fee being forfeited to the panel. If a party desiring to file an appeal is unable to pay the filing fee because of financial hardship, the party shall submit a completed Request for Filing Fee Waiver form at the same time the request for review is filed. The Request for Filing Fee Waiver form is attached to this Decision. If the filing fee is not waived, the party must pay the filing fee within fifteen days of the date of receipt of the order denying waiver of the filing fee. Requests for administrative review will not be accepted unless accompanied by the filing fee or a completed Request for Filing Fee Waiver form at the time of filing." PLEASE MAKE YOUR CHECK PAYABLE TO THE "SC PROCUREMENT REVIEW PANEL."

LEGAL REPRESENTATION: In order to prosecute an appeal before the Panel, business entities organized and registered as corporations, limited liability companies, and limited partnerships must be represented by a lawyer. Failure to obtain counsel will result in dismissal of your appeal. *Protest of Lighting Services*, Case No. 2002-10 (Proc. Rev. Panel Nov. 6, 2002) and *Protest of The Kardon Corporation*, Case No. 2002-13 (Proc. Rev. Panel Jan. 31, 2003); and *Protest of PC&C Enterprises*, *LLC*, Case No. 2012-1 (Proc. Rev. Panel April 2, 2012). However, individuals and those operating as an individual doing business under a trade name may proceed without counsel, if desired.
