DIGEST

ANALYSIS

This solicitation was issued by the South Carolina Department of Education to acquire closed captioning services. An Intent to Award was posted to Kaltura, Inc. on June 6, 2017. AST protests on June 12, 2017, that the while the stated intent of the solicitation is to "meet accessibility requirements" and the solicitation required at least a 95% accuracy rate, a 95% accuracy is extremely poor and falls below an acceptable standard to provide effective and equal communications for users of captioning as required by the ADA.

The solicitation was posted on May 1, 2017 and included the following requirements:

These video and audio components require transcripts, closed captioning and searchable metadata to meet accessibility requirements.

Many courses offered by VirtualSC contain video and audio components and require transcripts, closed captioning and searchable metadata to meet accessibility requirements.

3.1.5 The captioning must be done by humans and have at least 95% accuracy.

3.2.3 The captioning must be done by humans and have at least 95% accuracy.

Protest Decision, page 3 Case No. 2017-155 July 7, 2017

Section 11-35-4210(1)(b) grants any actual bidder, offeror, or contractor the right to protest the award of a contract with one exception:

Any actual bidder, offeror, contractor, or subcontractor who is aggrieved in connection with the intended award or award of a contract shall protest to the appropriate chief procurement officer in the manner stated in subsection (2)(b) within ten days of the date award or notification of intent to award, whichever is earlier, is posted in accordance with this code; <u>except that a matter that could have been raised pursuant to (a) as a protest of the solicitation may not be raised as a protest of the award or intended award of a contract.</u>

(emphasis added)

The intent of the solicitation to "meet accessibility requirements" and the 95% accuracy rate were published in the solicitation and concerns about any inconsistency between the two could have been raised as a protest of the solicitation but cannot be raised as a protest of the award.

DECISION

For the reasons stated above, the protest of Automatic Synch Technologies, Inc. is dismissed.

We wish to protest the award made in the recent solicitation for closed captioning services (solicitation 5400013380). To better analyze the decision made, we requested a copy of the winning proposal but were told that there was no proposal provided by the winning bidder (although the solicitation states a narrative is required on p.19, so not providing one would seem to be non-responsive to the solicitation). That makes it difficult to assess exactly what product the winning vendor is providing or how well it meets various criteria outlined in the solicitation. However, it is our understanding that the service bid by the winning vendor is the "Premium" captioning service from Cielo24 and resold by Kaltura (see p.1 of attached product description). This service offers an accuracy rate of 95% to 96%.

While we note that the solicitation requirements are almost an exact match to the Cielo24/Kaltura "Premium" captioning service, we also note that the stated intent of the solicitation is to "meet accessibility requirements" (p.5 of solicitation). A 95% accuracy rate is extremely poor, and falls far below an acceptable standard to provide effective and equal communication for users of captioning, as required by the ADA. Choosing such a low quality captioning service not only does a disservice to your students, but could potentially leave the state exposed to liability for non-compliance with accessibility laws. Recent decisions from the Office of Civil Rights have clearly indicated that low quality captioning does not fulfill accessibility requirements.

We respectfully ask that you reconsider the quality level of the captioning service you select and ensure your choice can meet the bar of providing equal and effective communication for your deaf and hard of hearing students.

STATEMENT OF RIGHT TO FURTHER ADMINISTRATIVE REVIEW

Protest Appeal Notice (Revised November 2016)

The South Carolina Procurement Code, in Section 11-35-4210, subsection 6, states:

(6) Finality of Decision. A decision pursuant to subsection (4) is final and conclusive, unless fraudulent or unless a person adversely affected by the decision requests a further administrative review by the Procurement Review Panel pursuant to Section 11-35-4410(1) within ten days of posting of the decision in accordance with subsection (5). The request for review must be directed to the appropriate chief procurement officer, who shall forward the request to the panel or to the Procurement Review Panel, and must be in writing, setting forth the reasons for disagreement with the decision of the appropriate chief procurement officer. The person also may request a hearing before the Procurement Review Panel. The appropriate chief procurement officer and an affected governmental body shall have the opportunity to participate fully in a later review or appeal, administrative or judicial.

FILE BY CLOSE OF BUSINESS: Appeals must be filed by 5:00 PM, the close of business. *Protest* of *Palmetto Unilect, LLC*, Case No. 2004-6 (dismissing as untimely an appeal emailed prior to 5:00 PM but not received until after 5:00 PM); *Appeal of Pee Dee Regional Transportation Services, et al.*, Case No. 2007-1 (dismissing as untimely an appeal faxed to the CPO at 6:59 PM).

FILING FEE: Pursuant to Proviso 111.1 of the 2016 General Appropriations Act, "[r]equests for administrative review before the South Carolina Procurement Review Panel shall be accompanied by a filing fee of two hundred and fifty dollars (\$250.00), payable to the SC Procurement Review Panel. The panel is authorized to charge the party requesting an administrative review under the South 11-35-4210(6), 11-35-4220(5), Carolina Code Sections 11-35-4230(6) and/or 11-35-4410...Withdrawal of an appeal will result in the filing fee being forfeited to the panel. If a party desiring to file an appeal is unable to pay the filing fee because of financial hardship, the party shall submit a completed Request for Filing Fee Waiver form at the same time the request for review is filed. The Request for Filing Fee Waiver form is attached to this Decision. If the filing fee is not waived, the party must pay the filing fee within fifteen days of the date of receipt of the order denying waiver of the filing fee. Requests for administrative review will not be accepted unless accompanied by the filing fee or a completed Request for Filing Fee Waiver form at the time of filing." PLEASE MAKE YOUR CHECK PAYABLE TO THE "SC PROCUREMENT REVIEW PANEL."

LEGAL REPRESENTATION: In order to prosecute an appeal before the Panel, business entities organized and registered as corporations, limited liability companies, and limited partnerships must be represented by a lawyer. Failure to obtain counsel will result in dismissal of your appeal. *Protest of Lighting Services*, Case No. 2002-10 (Proc. Rev. Panel Nov. 6, 2002) and *Protest of The Kardon Corporation*, Case No. 2002-13 (Proc. Rev. Panel Jan. 31, 2003); and *Protest of PC&C Enterprises, LLC*, Case No. 2012-1 (Proc. Rev. Panel April 2, 2012). However, individuals and those operating as an individual doing business under a trade name may proceed without counsel, if desired.
