DIGEST

Protest of award below statutory threshold is dismissed. The protest letter of Creative Custom Products (CCP) is included by reference. (Attachment 1)

AUTHORITY

The Chief Procurement Officer¹ (CPO) conducted an administrative review pursuant to S.C. Code Ann. §11-35-4210(4). This decision is based on materials in the procurement file and applicable law and precedents.

BACKGROUND

Piedmont Technical College (PTC) advertised its intention to award a sole source contract to ConsuLab- Georgia Educational Solutions on November 8, 2019 for an Engine Performance Trainer, which is a single "operating engine mounted on a mobile stand." CCP filed its protest with the Chief Procurement Officer on November 14, 2019 alleging that its trainer is of equal or better quality and better value/pricing and requested PTC issue a competitive bid to meet its needs.

ANALYSIS

In PTC's published sole source determination, PTC estimates that the total potential value of this transaction is \$16,750.00. (Attachment 2) Section 11-35-4210(1)(d) limits the right to protest to those procurements greater than \$50,000:

The rights and remedies granted by subsection (1) and Section 11-35-4410(1)(b) are not available for contracts with an actual or potential value of up to fifty thousand dollars.

The statute limits the right to protest to awards greater than \$50,000 and this award is only for \$16,750. The CPO is only authorized to review protests as authorized by the Code. Consequently, the CPO lacks jurisdiction to review the merits of this protest.

In spite of this statutory limitation, PTC's Automotive Academic Program Instructor did compare the ConsuLab and CCP's products and found that they were not comparable. (Attachment 3)

DECISION

For the reasons stated above, the protest of Creative Custom Products is dismissed.



Good Morning Gerald and Brian,

I have taken a few minutes to compare the two companies and have noticed some differences that would make the Consulab trainer a better option.

- The Consulab trainer is based on an engine that we use in class to train students on engine mechanical repairs, so there is the familiarity/continuity of them being identical engines
- The CCP trainer does appear to have the same basic setup as the Consulab trainer, with a few exceptions that I feel are important to our program:
 - 1. It is based on an engine of which we don't have any other units of
 - 2. The Consulab trainer can be expanded upon with an electronically programmable fault box, a huge advantage in creating faults for students to troubleshoot, without the risk of damaging existing sensors, connectors & other sensitive components.
 - The CCP trainer does not have an ECM/PCM breakout box included for students to perform circuit testing without disconnecting/reconnecting the ECM/PCM and causing unnecessary wear on the terminals in these units.
 - 4. The CCP offerings are not equipped with GDI (gasoline Direct Injection), an extremely important part of an engine performance course and is the latest in fuel injection technology.

These are my observations based only on what I'm seeing when reviewing both websites side by side and comparing the CCP General Motors 3.8L engine to Consulabs EM-140 G4FD Hyundai/Kia 1.6L Gasoline Direct Injection Engine Trainer.

I hope this helps.

STATEMENT OF RIGHT TO FURTHER ADMINISTRATIVE REVIEW

Protest Appeal Notice (Revised June 2019)

The South Carolina Procurement Code, in Section 11-35-4210, subsection 6, states:

(6) Finality of Decision. A decision pursuant to subsection (4) is final and conclusive, unless fraudulent or unless a person adversely affected by the decision requests a further administrative review by the Procurement Review Panel pursuant to Section 11-35-4410(1) within ten days of posting of the decision in accordance with subsection (5). The request for review must be directed to the appropriate chief procurement officer, who shall forward the request to the panel or to the Procurement Review Panel, and must be in writing, setting forth the reasons for disagreement with the decision of the appropriate chief procurement officer. The person also may request a hearing before the Procurement Review Panel. The appropriate chief procurement officer and an affected governmental body shall have the opportunity to participate fully in a later review or appeal, administrative or judicial.

FILING FEE: Pursuant to Proviso 111.1 of the 2019 General Appropriations Act, "[r]equests for administrative review before the South Carolina Procurement Review Panel shall be accompanied by a filing fee of two hundred and fifty dollars (\$250.00), payable to the SC Procurement Review Panel. The panel is authorized to charge the party requesting an administrative review under the South Sections 11-35-4210(6), 11-35-4220(5), 11-35-4230(6) Carolina Code and/or 11-35-4410...Withdrawal of an appeal will result in the filing fee being forfeited to the panel. If a party desiring to file an appeal is unable to pay the filing fee because of financial hardship, the party shall submit a completed Request for Filing Fee Waiver form at the same time the request for review is filed. [The Request for Filing Fee Waiver form is attached to this Decision.] If the filing fee is not waived, the party must pay the filing fee within fifteen days of the date of receipt of the order denying waiver of the filing fee. Requests for administrative review will not be accepted unless accompanied by the filing fee or a completed Request for Filing Fee Waiver form at the time of filing." PLEASE MAKE YOUR CHECK PAYABLE TO THE "SC PROCUREMENT REVIEW PANEL."

LEGAL REPRESENTATION: In order to prosecute an appeal before the Panel, business entities organized and registered as corporations, limited liability companies, and limited partnerships must be represented by a lawyer. Failure to obtain counsel will result in dismissal of your appeal. *Protest of Lighting Services*, Case No. 2002-10 (Proc. Rev. Panel Nov. 6, 2002) and *Protest of The Kardon Corporation*, Case No. 2002-13 (Proc. Rev. Panel Jan. 31, 2003); and *Protest of PC&C Enterprises, LLC*, Case No. 2012-1 (Proc. Rev. Panel April 2, 2012). However, individuals and those operating as an individual doing business under a trade name may proceed without counsel, if desired.
