# **DIGEST**

Protest of sole source is granted. EKF Diagnostics' (EKF) letter of protest is included by reference. (Attachment 1)

# **AUTHORITY**

The Chief Procurement Officer<sup>1</sup> (CPO) conducted an administrative review pursuant to S.C. Code Ann. §11-35-4210(4). This decision is based on materials in the procurement file and applicable law and precedents.

### **BACKGROUND**

Intent to Sole Source Advertised 11/07/2019 Protest Received 11/14/2019

The South Carolina Department Health and Environmental Control (DHEC) published its intent to award a sole source contract to Hemocue America for hemoglobin analyzers that measure hemoglobin levels in whole blood, and supplies including dedicated microcuvettes that are compatible with existing Hemocue America analyzers used in DHEC Health Department laboratories statewide. EKF protested that there are other sources for hemoglobin analyzers.

## **ANALYSIS**

# DHEC explains:

These hemoglobin analyzers are used in DHEC clinics statewide to screen hemoglobin for all WIC clients (pre-natal and post-partum women, infants 9-12 months, and children ages 1-5). This is in compliance with a Federal requirement of the WIC program that requires all clients to be screened when they are accepted into the program. The screening is used to determine nutritional deficiencies that may be present, leading to targeted nutritional education or, if necessary, medical referral. There are three principle components in the system: (1) the analyzer is the device that is used to read the blood sample, (2) the microcuvettes are the consumables used to collect the blood sample, and (3) R&D controls are used to validate and calibrate the analyzers (a process that must be performed daily for each device).

Regulation 19-445.2105(B)(1) provides that a sole source may be necessary "where the compatibility of equipment, accessories, or replacement parts is the paramount consideration." Statewide, DHEC has over 100 Hemocue analyzers and over 100 staff members that are trained to use these systems. We believe that compatibility with existing systems, and the staff trained to use the existing equipment, is a paramount consideration and therefore warrants the continued use of the Hemocue analyzers and supplies.

Switching to a different system would present an unreasonable hardship to the agency, and would very likely result in gaps in service to clients during the transition that would be required. Initial training for each person --- over 100 staff members distributed across dozens of DHEC locations statewide --- must be done by a CLIA general supervisor. Then, each staff member being trained must stick 20 patients each twice and the readings must be within 0.5 of each other before the employee is considered to be certified to use the device. This translates to

more than 4,000 patient sticks that would be necessary to transition current staff

to a new system.

Based on past experience DHEC believed that HemoCue America was the exclusive authorized

dealer in the United States for the HemoCue hemoglobin analyzers and their respective dedicated

cuvettes for distribution to state and county public health customers.

In verifying its understanding of the marketplace, DHEC learned that while formerly HemoCue's

agreements with their resellers prohibited those resellers from offering to Public Health entities,

this is no longer the case. (Attachment 3) "In cases of reasonable doubt, competition must be

solicited." Appeal by Beckman Instruments, Panel Case No. 1995-6.

DHEC has determined that in this case a sole source contract is not appropriate and will solicit

for a new contract.

**DECISION** 

The intended award to Hemocue America is cancelled and this procurement is remanded to the

Department of Health and Environmental Control for processing in accordance with the

Consolidated Procurement Code.

#### Mr. Spicer,

On November 7, 2019, SC DHEC posted public notice of an "Intent to sole source," in accordance with §11-35-1560(A), for portable hemoglobin analyzers that measure hemoglobin levels in whole blood, and supplies including dedicated microcuvettes that are compatible with existing Hemocue America analyzers used in DHEC Health Department laboratories statewide. On November 14, EKF Diagnostics submitted a Protest of this Intent to Sole Source, stating that they "would like to offer the State another option."

These hemoglobin analyzers are used in DHEC clinics statewide to screen hemoglobin for all WIC clients (pre-natal and post-partum women, infants 9-12 months, and children ages 1-5). This is in compliance with a Federal requirement of the WIC program that requires all clients to be screened when they are accepted into the program. The screening is used to determine nutritional deficiencies that may be present, leading to targeted nutritional education or, if necessary, medical referral. This translates to more than 4,000 patient sticks that would be necessary to transition current staff to a new system.

Be aware also that all three of the Hemocue items that are a part of this system are available on the NASPO contract with Fisher Scientific. However, this is a non-mandatory state contract and we have chosen to instead go directly to the manufacturer, Hemocue, because the items are available direct at significantly lower prices than from Fisher.

**Please see below.** In a phone call yesterday with Hemocue representatives Danalu Smith and Mark Bellwood, we learned that while formerly their agreements with their resellers prohibited those resellers from offering to Public Health entities, this is no longer the case. Since the market has changed and resellers are available, we no longer have a "sole source" situation. We will be soliciting for a new contract instead. Since our current contract expires December 31, it will be necessary for us to do a short term extension on the current contract to provide continuity until a new contract can be solicited and awarded.

In the past, our distribution agreements restricted distributor access to certain market segments. In the last few years, HemoCue no longer restricts access to the Hb201+ by our distributors. Instead, distributors are generally unable to access the Public Health segment since their access cost is significantly more than our standard Public Health price of \$168.00 per box.

# STATEMENT OF RIGHT TO FURTHER ADMINISTRATIVE REVIEW

Protest Appeal Notice (Revised June 2019)

The South Carolina Procurement Code, in Section 11-35-4210, subsection 6, states:

(6) Finality of Decision. A decision pursuant to subsection (4) is final and conclusive, unless fraudulent or unless a person adversely affected by the decision requests a further administrative review by the Procurement Review Panel pursuant to Section 11-35-4410(1) within ten days of posting of the decision in accordance with subsection (5). The request for review must be directed to the appropriate chief procurement officer, who shall forward the request to the panel or to the Procurement Review Panel, and must be in writing, setting forth the reasons for disagreement with the decision of the appropriate chief procurement officer. The person also may request a hearing before the Procurement Review Panel. The appropriate chief procurement officer and an affected governmental body shall have the opportunity to participate fully in a later review or appeal, administrative or judicial.

The panel is authorized to charge the party requesting an administrative review under the South Sections 11-35-4210(6), 11-35-4220(5), 11-35-4230(6) Carolina Code and/or 4410...Withdrawal of an appeal will result in the filing fee being forfeited to the panel. If a party desiring to file an appeal is unable to pay the filing fee because of financial hardship, the party shall submit a completed Request for Filing Fee Waiver form at the same time the request for review is filed. [The Request for Filing Fee Waiver form is attached to this Decision.] If the filing fee is not waived, the party must pay the filing fee within fifteen days of the date of receipt of the order denying waiver of the filing fee. Requests for administrative review will not be accepted unless accompanied by the filing fee or a completed Request for Filing Fee Waiver form at the time of filing." PLEASE MAKE YOUR CHECK PAYABLE TO THE "SC PROCUREMENT REVIEW PANEL."

LEGAL REPRESENTATION: In order to prosecute an appeal before the Panel, business entities organized and registered as corporations, limited liability companies, and limited partnerships must be represented by a lawyer. Failure to obtain counsel will result in dismissal of your appeal. *Protest of Lighting Services*, Case No. 2002-10 (Proc. Rev. Panel Nov. 6, 2002) and *Protest of The Kardon Corporation*, Case No. 2002-13 (Proc. Rev. Panel Jan. 31, 2003); and *Protest of PC&C Enterprises*, *LLC*, Case No. 2012-1 (Proc. Rev. Panel April 2, 2012). However, individuals and those operating as an individual doing business under a trade name may proceed without counsel, if desired.
