The newly developed park master plan may include upgrades to utilities (electrical, water, street lighting), landscape design (to include plant material, irrigation design, hardscapes / pavement treatment, space for public sculpture), design / construction of covered gazebo / bandstand, design / installation of water feature (fountain / splash pad), & parking design.

WATER DISTRIBUTION IMPROVEMENTS IN LAURENS COUNTY

Laurens County Water & Sewer Commission (LCWSC) Is Requesting Proposals from qualified engineering firms to provide professional design & limited inspection services for water distribution improvements to include the abandonment of approximately 1,800 LF of existing 1" & 2" galvanized steel "back alley" water distribution mains, & the relocation of approximately 43 residential water services. The existing waterlines that serve the area were installed in the 1940s. Larger 6" ductile iron mains were later installed along the street for fire protection, but the houses were not tapped into the newer lines. Most of the residences can be served by the newer lines by rerouting the service lines to the existing waterlines along the street. Approximately 360 LF of new 6-inch PVC water main will be constructed to serve the 6 houses on South Hampton Street that can't be served by existing lines once the old lines are abandoned.

Sewer Collection System Improvements Include the trenchless rehabilitation of approximately 2,500 LF of 8" gravity main & relocation of approximately 38 residential sewer services. These existing sewer services will be replaced with PVC pipe & located in a separate trench from the new water service lines, thereby alleviating cross contamination. Also included would be the upgrading of 2 manholes in the project area. The trenchless technique will include point upgrades of taps & allow for installation of proper taps & cleanouts at the edge of the right-of-way. The cleanouts will allow for ease of maintenance & mark the edge of the sewer main for both residents & LCWSC staff.

The Project Area Is In The Joanna Mill Village located east of the City of Clinton, SC. This project, Joanna S. Hampton Water & Sewer Upgrade Project (CDBG# 4-CI-14-013), is funded with Community Development Block Grant (CDBG) funds. It is anticipated that the consultant will be selected based on the response to this proposal using the following weighted criteria: qualifications 35%; similar projects 20%; CDBG experience 20%; response to proposal 20%; & cost of services 5%.
