BICYCLE MASTER PLAN FOR CITY OF TRAVELERS REST

The City of Travelers Rest is soliciting proposals from firms to provide professional development of a Bicycle Master Plan.

The City of Travelers Rest is interested in developing a Bicycle Master Plan for future development of its multi-modal transportation network. Having such a plan is critical for the City to understand biking system needs & how to best prioritize the expenditure of limited capital resources for greenways, bikeways & bike lanes. This plan will encompass the entire City, but will also focus additional emphasis on the Swamp Rabbit Trail & potential spurs & greenways.
