This matter is before the Chief Procurement Officer for Construction (CPOC) pursuant to a request by Coastal Empire Fire & Security, Inc., under the provisions of section 11-35-4210 of the South Carolina Consolidated Procurement Code, for an administrative review of the Ridgeland Correctional Institute – Fire Alarm Replacement bid (“the Project”), for the South Carolina Department of Corrections (DOC). Coastal protests DOC’s posting of a Notice of Intent to Award a contract for the project to Southeastern Fire Control, Inc.

**NATURE OF THE PROTEST**

Coastal’s protest is attached and incorporated herein by reference. [Ex. A] Coastal’s protest contains the following items of protest and allegations:

1. Coastal alleges that Southeastern is not responsible and its bid is non-responsive because its bid price “appears” to be below Coastal’s cost.
2. Coastal asserts that Southeastern’s bid may be in violation of Section 39-5-150 of the South Carolina Trusts, Monopolies and Restraints of Trade Act and the “Federal Trade Commission Antitrust Law”.

Coastal’s requested remedy is that the CPOC take action to determine if Southeastern’s low bid is responsible and accurate with respect to pricing.<sup>1</sup>

<sup>1</sup> After bid opening, DOC, as a part of its responsibility determination, asked Southeastern to confirm its bid price, which it did.

## FINDINGS OF FACT

The following dates and facts are relevant to the protest:

1. On October 13, 2008, DOC solicited bids to perform the work of the Project. [Ex. B]
2. By the time for receiving and opening bids, November 26, 2008, DOC received three bids. [Ex. C]
3. Southeastern submitted the low bids of \$138, 960.00 on Base Bid #1 and \$150,450.00 on Base Bid #2.
4. Coastal submitted the second low bids of \$260,057.54 on Base Bid #1 and \$293,007.94 on Base Bid #2.
5. On December 9, 2008, DOC posted a Notice of Intent to Award a contract for the work of Base Bid #2 to Southeastern. [Ex. D]
6. On December 11, 2008, Coastal submitted its protest to the CPOC.

## DISCUSSION

### Responsiveness

Coastal alleges that Southeastern's bid was not responsive because Southeastern's listed bid price was allegedly below cost. Responsiveness is determined on the face of the bid. Therefore, if Southeastern listed any price in the spaces on the bid form for doing so, Southeastern's bid is responsive. *See e.g. B&M Cillessen Construction Co, Inc., 2001 WL 611472 (Comp. Gen.), B-28744.2, 2001 CPD 100.*<sup>2</sup> A review of Southeastern's bid form shows that Southeastern inserted a bid price into both spaces on the form for doing so and whether or not these prices were below cost is not relevant to the issue of responsiveness.

### Responsibility

A determination of responsibility is required by S.C. Code Ann. § 11-35-1810, which states "[r]esponsibility of the bidder or offeror shall be ascertained for each contract let by the State..." A procurement officer's determination of responsibility is final and conclusive unless it is "clearly erroneous, arbitrary, capricious, or contrary to law." *See S.C. Code Ann. § 11-35-2410(A)*. The protestant has the burden of proving that the procurement officer's determination is "clearly erroneous, arbitrary, capricious, or contrary to law." *See Brantley*. Assuming that Coastal's allegation that Southeastern's bid

is a below cost bid is true, this fact by itself is not sufficient to establish that the procurement officer's determination of responsibility is "clearly erroneous, arbitrary, capricious, or contrary to law." See e.g. *B&M Cillessen Construction Co, Inc.*, 2001 WL 611472 (Comp. Gen.), B-28744.2, 2001 CPD 100; *Advanced Modular Space, Inc.*, 1995 WL 592774 (Comp. Gen.), B-265860, 95-2 CPD P 168.

Trusts, Monopolies and Restraints of Trade Act


Coastal suggests that Southeastern's low bid might be an attempt to injure competitors in a conspiracy to form a monopoly in violation of S.C. Code Ann. § 39-3-150. Aside from the fact that this Act only applies to the sale of commodities, not offering to provide construction services, if Coastal believes that it is being harmed by an illegal conspiracy to restrain trade, its proper course of action is to file a complaint with the Circuit Solicitor, not file a protest under the Procurement Code. The protest of an Intent to Award is not the appropriate mechanism to complain of an attempt to monopolize. The Attorney General and the solicitor of each circuit in which the offense is committed are the proper parties to enforce the provisions of the law. See S.C. Code Ann. § 39-3-190.

**DECISION**

It is the decision of the Chief Procurement Officer for Construction that Southeastern's bid was responsive on its face and that DOC's determination that Southeastern was a responsible bidder was not clearly erroneous, arbitrary, capricious, or contrary to law.

For the foregoing reasons Protest denied.

## STATEMENT OF RIGHT TO FURTHER ADMINISTRATIVE REVIEW

The South Carolina Procurement Code, in Section 11-35-4210, subsection 6, states:

(6) Finality of Decision. A decision pursuant to subsection (4) is final and conclusive, unless fraudulent or unless a person adversely affected by the decision requests a further administrative review by the Procurement Review Panel pursuant to Section 11-35-4410(1) within ten days of posting of the decision in accordance with subsection (5). The request for review must be directed to the appropriate chief procurement officer, who shall forward the request to the panel or to the Procurement Review Panel, and must be in writing, setting forth the reasons for disagreement with the decision of the appropriate chief procurement officer. The person also may request a hearing before the Procurement Review Panel. The appropriate chief procurement officer and an affected governmental body shall have the opportunity to participate fully in a later review or appeal, administrative or judicial.

**FILING FEE:** Pursuant to Proviso 83.1 of the 2008 General Appropriations Act, "[r]equests for administrative review before the South Carolina Procurement Review Panel shall be accompanied by a filing fee of two hundred and fifty dollars (\$250.00), payable to the SC Procurement Review Panel. The panel is authorized to charge the party requesting an administrative review under the South Carolina Code Sections 11-35-4210(6), 11-35-4220(5), 11-35-4230(6) and/or 11-35-4410(4). . . . Withdrawal of an appeal will result in the filing fee being forfeited to the panel. If a party desiring to file an appeal is unable to pay the filing fee because of hardship, the party shall submit a notarized affidavit to such effect. If after reviewing the affidavit the panel determines that such hardship exists, the filing fee shall be waived." 2008 S.C. Act No. 310, Part IB, § 83.1. 

This letter is our written protest of the *Notice of Intent to Award* on the above referenced project.

The total amount of the low bidder's Base Bid #2 appears to be below our cost (SE-370 and Bid Tabulation Sheet enclosed). Which, may be in violation of SECTION 39-3-150 "Sale at less than cost for purpose of injuring competitors is conspiracy to form monopoly;" of the South Carolina Code of Laws and the Federal Trade Commission Antitrust Law.

The State should take appropriate action to determine if this low bid is responsible and accurate in their material take-off, pricing and the number of buildings included in their bid. As you may well be aware of, acceptance of such a low bid can have dire results in the quality of the work to be performed, repeated requests for additional work with exorbitant pricing to make up for the difference in the Base Bid costs', and the possibility of the contractor defaulting on the contract leaving the project unfinished. The risks involved in an incomplete life safety system are too great in a large facility of this type.

Whether or not the low bidder intentionally quoted below cost is for the State to determine. Our intentions are to insure that the SC Department of Corrections receives a quality system at fair market value.


