### The 10% Rule, STC Use, and Multistate Agreements

#### A reminder...

Often in the world of contracting, market conditions can, and do, change rapidly. It is not unheard of that, for some contracts, before the ink is barely dry, market pricing changes significantly. In instances where "the same supplies, services, or information technology are offered at a price that is at least ten percent less than the term contract price, [an agency] may purchase from the vendor offering the lower price after first offering the vendor holding the contract the option to meet the lower price." This is what we commonly call the 10% rule found in South Carolina Code of Laws §11-35-310(37). This allows agencies to gain the benefit of lower market conditions under the same terms and conditions as the awarded contract.



#### Another reminder...

Section 11-35-310(37) makes it mandatory that governmental bodies, as defined in §11-35-310(18), procure supplies, services, or information technology needs from the State's established term contracts during the contract term. **However**, it is not mandatory for local governmental entities to purchase off the State's term contracts. Local governmental entities purchasing off state term contracts should consult their local governing body's policies regarding purchasing off the State's term contracts.

#### A final reminder...

The State of South Carolina often participates in multistate cooperative purchasing with sister states. We do so through the National Association of State Procurement Officials (NASPO). NASPO is composed of the 50 states, the District of Columbia, the U.S. Virgin Islands, Puerto Rico, and Gaum. The Division of Procurement Services' authorization to participate in cooperative purchasing on behalf of the State is found in Article 19 of the Code §11-35-4810 et. seq.

It is not uncommon for our office to be asked by contract holders or an agency to participate in a NASPO contract after the contract has been solicited and awarded, but in which we did not participate. The State's procurement code does not allow us to participate in a cooperative contract unless we have done so under the requirements of §11-35-4810. Plain speak - we cannot sign a participating addendum after the fact nor give approval that that be done. It is not lawful. So, if there are multistate cooperative contracting opportunities you think we should pursue as being in the interest of the State, please let us know.

We have issued two Participating Addendums (PAs) so far under this NASPO offering; one to Clark Equipment Company (Bobcat) and one to JCB, Inc. We are currently negotiating an additional PA with John Deere and hope to have that completed soon. NASPO is still in negotiations with additional vendors, and we will work to issue PAs to those vendors as soon as the awards are published by NASPO.
