1. Minor repairs to concrete caps of nine existing sheetpile groins.
2. Rehabilitation of nine (9) existing stone and timber sheeting groins in various states of disrepair.
3. Selective demolition and disposal of derelict timber groin elements. Excavation of all or portions of the existing groins, including visible and buried large armor stones, to the required foundation depths. Stockpiling of excavated stone for re-use in the rehabilitation.
4. Use of stone filled marine mattresses and geogrid composite material as foundations for the rehabilitated structure.
5. Placing new and excavated stone to the specified lines and grades of the rehabilitated groins and grouting the outer layers of stone in place to form a monolithic structure. Newly rehabilitated groins will have no timber elements.
6. Restoration of the surrounding site, including disturbed dunes, private dune walkovers, or other infrastructure to pre-project conditions.
7. Coordination with on-site Federal nourishment Contractor during the entirety of the project.
8. Environmental compliance, as described in the project specifications and state and federal construction permits.
