INTRODUCTION

The City of Rock Hill "City" wishes to receive detailed Technical Proposals for a Pavement Management Software System (PMS) and related Consulting Services as outlined in this Request for Qualifications (RFQ). The City of Rock Hill maintains approximately 225 centerline miles of roadway delineated into approximately 2000 road segments. The proposed solution will be a vendor hosted web-based pavement management soft-

ware system. The system will allow the City of Rock Hill to integrate and maintain an inventory, analyze condition data, track construction history, and conduct multi-year analyses to guide sound, defensible decisions about investment of available resources for pavement maintenance and rehabilitation.

SUBMISSION OF PROPOSALS
