BEACH RENOURISHMENT

The City of Isle of Palms is seeking bids for the Isle of Palms Beach Nourishment Project. Work to include the provision of labor, materials, equipment, and services required to complete beach nourishment at Isle of Palms, Charleston County, South Carolina. The Work is generally described as follows:

- A. Dredging by ocean-certified cutterhead suction dredge, placement, grading, and environmental protection as specified under federal and state permits of up to 1,400,000 cubic yards on 8,800 linear feet of Isle of Palms in two reaches.
- B. Sand is to be dredged from the designated offshore borrow areas situated approximately 1-2 miles off the south end of the project. The priority borrow areas encompass ~196 acres, and the maximum depth of excavation allowed is 7 ft below existing grade, plus one foot of overdredge.
- C. The Work shall be conducted between 1 October 2017 and 30 March 2018.
- D. If required, tilling of the beach in accordance with requirements specified in the Project Manual.
- E. Restoration of access and infrastructure to conditions existing before construction.
