Description Of The Project: This project consists of re-roofing and repairs of the Mullins High School TPO roof. The project consists of installation of a new 20 year, fully adhered or mechanically attached TPO roof over rigid insulation. The existing IRMA membrane is to remain, undisturbed where possible. Rigid insulation not saturated or damaged may be reused, but boards with tears, cracks or chips shall be replaced with new matching insulation. The existing perimeter nailers must be secure, requiring removal of edge metal and roofing at perimeter as required to visually verify that fasteners are seating properly to existing 2x framing below the nailers. Some repair of existing mansard panels applied over existing masonry is required. See drawings for extent and location.
