PPE & Cleaning Supply Resources

The following resource information is provided to assist our customers in determining the best path for returning to work. **It is important to note** that what all States are currently experiencing is an extreme shortage in the availability of certain high demand items in the worldwide supply chain, not a shortage of resources **where** to obtain them.

Medical supply providers are typically the source for most of these items. However, medical supply providers are still operating restrictions to provide PPE to those areas with the most need before filling other orders.

If you are a medical facility that has a long history of ordering PPE from a medical supply company, you will have a higher priority than someone just wanting to buy masks for their office staff. If you are just trying to buy masks for your office staff, you must understand the medical facilities have a higher priority and you may have to wait longer.

If you are not already an MMCAP member, follow the instructions at the Contractor links below. These contracts all have access to the Contractors entire catalog.

Facilities Material, Repair and Operation (MRO) Contracts – the MRO contracts already have some PPE items on them (various types of masks for general or specialized use, protective suits, gloves etc.) and some of them are beginning to include some of the more specialized PPE (N95 masks, gowns, etc.). These contracts also have cleaning supplies such as various types of cleaning chemicals, bleach, disinfectants, hand sanitizer, etc. These contracts all have access to the Contractors entire catalog, although there are restrictions on individual items with a unit price of more than \$10,000.00, or items already available on other STCs. NON-STC RESOURCES FOR PPE/CLEANING SUPPLIES

Any purchase using these resources would not be considered a State Term Contract purchase. These purchases must fall under another provision of the Consolidated Procurement Code (small purchases, COTS, emergency, etc.) or otherwise be made in accordance with your entity's procurement laws, regulations, or rules.

State Term Contract Vendors - Some state term contract holders provide PPE and cleaning supplies that are not part of their contracts. For example, the two contractors for toilet paper/paper towels, Southeastern Paper and Dade Paper, may also sell cleaning supplies and PPE. You may order from these vendors; however, orders for cleaning supplies/PPE would not be considered State Term Contract purchases.

Vendors Currently Providing Products – The following is a list of vendors who successfully delivered to the State for the listed supplies through the Emergency Operations Center. They have proven to have access to PPE and cleaning supplies, although delivery is going to vary not just between vendors, but with the same vendor and different products.
