We are pleased to have finished positioning the can liner contracts and appreciate everyone’s patience while we worked through some key issues. The contract sheets consolidate a great deal of information onto relatively few pages for contract users to reference when placing orders. While the procurement officer, who authors the contract sheets, has been deeply immersed in the commodity’s market for approximately 6 months, the contract users have not. Therefore, what is perfectly clear to the author, may be vague or unclear to the contract user. With that in mind, please provide us feedback regarding both the format and content of the contract sheets.

I. INTRODUCTION & Guideline for Contract Use: The can liners were split into two separate solicitations, Low Density and High Density. The two Solicitations represent two types of liners that are readily available on the market. We have historically contracted for Low and High Density liners. The following table provides the basic characteristics associated with each type liner:

CHARACTERISTIC / DESCRIPTION	LOW DENSITY	HIGH DENSITY
Thickness to Achieve Comparable Strength	Thicker	Thinner
How Thickness is Measured	Mils	Microns
Properties Under Stress	- Stretches Until It Fails - Failure tends to be more limited to the point of stress	- Little stretching - Rips / Tears when fails - Failure tends to extend beyond the point of stress
Example Applications	Kitchen and lawn trash bags	Thin, light grocery bags that rip when they fail
Shelf Life	Long	Long

Since we have adequate competition, we elected to award to the lowest 2 offerors for each liner type. This is truly a “Dual Award” and not a “Primary & Secondary Award” approach. Contract users can order from 1 or both contractors as best meets their operational needs with no additional documentation. This provides some contract user choice and a readily available solution for contractor temporary stock outages or contract termination.

Pricing Strategies: There are 4 separate prices established for each size and type liner based on order quantities. Furthermore, the prices used when placing orders are based on the total number of cases for each purchase order. Line items can be combined to achieve a better price point.

Pricing for each size and type can liner will be established for the following order quantity ranges:

1. 25 – 99 cases
2. 100- 199 cases
3. 200 – 999 cases
4. 1,000 cases or more

The price used for each size and type can liner when placing orders will be based on the total number of cases per order. In other words, an order consisting of 4 line items of 250 cases each (250 + 250 + 250 + 250 = 1,000) will receive the “1,000 case or more” pricing for all 4 line items.”

We encourage contract users to consider the potential to consolidate orders to achieve lower unit prices.

Additionally, contract users should keep in mind the overall low offeror for each lot was not necessarily low for every line item within the lot. With this in mind, we have highlighted the lower of the 2 prices awarded for each line item (example: **\$15.50**).

Since there are 2 key pricing variables (total # of cases per order, and lowest price offered per line item), it may be necessary to price out an order or orders multiple ways to determine the best value for your organization.

II. Key Terms / Definitions to Use with Pricing Tables:

Size is listed in inches. Items offered must be within +/- 1 inch of the stated size.

Thicknesses are expressed as “MINIMUMS” in MILS for High Density liners. They are expressed as “MINIMUMS” in MICRONS for Low Density liners. Items offered must be at least as thick as the stated minimum thickness.

Bag Capacities are expressed as “MINIMUMS” in gallons. Items offered must be rated to hold at least the stated minimum bag capacity.

Color is stated as either “Dark,” “Clear,” Translucent Blue or “Standard.” Low Density line items are specified to come in dark, with the exception of lines 41-44 and 57-60 which are specified to come in “standard” color. Translucent Blue liners are only available in translucent blue with the “Recycle” logo imprinted. All High Density items are to be clear in color.

Net Case Weight (NCW): The net case weight is the weight of the can liners **ONLY** expressed in pounds (to the nearest 10th (0.1) of a pound). Stated another way, it is the total case weight less the weight of the packaging expressed in pounds (to the nearest 10th (0.1) of a pound). The weights are listed as minimums. Net Case Weights offered may exceed but may not be less than the weights specified on the bid schedule.

NOTE: Net Case Weight must be stenciled on the outside of the cases in order to help with contract compliance. It provides a fairly straightforward and inexpensive way to roughly confirm the size and thickness specifications. Should a contract user become concerned that the liners provided are not the quality level specified, they should:

1. Verify the NCW listed on the case is the same or greater than the NCW listed on the pricing table contained in these contract sheets.
2. Weigh the case full and unopened.
3. Remove the liners, and weigh the packaging.
4. Subtract the weight of the packaging from the weight of the full case. It should equal or exceed the NCW listed on the pricing table contained in these contract sheets.

NOTE: An abbreviated version of the contractor’s name is listed at the top of the unit price columns. When placing an order, reference the contractors’ detailed ordering information listed in the last section of the contract sheets.
