NOTABLE CLAUSES

Prime Contractor Responsibilities

The Contractor will be required to assume sole responsibility for the complete effort as required by this solicitation. The State will consider the Contractor to be the sole point of contact with regard to contractual matters. In order to provide effective customer service to Using Governmental Units, the Contractor may utilize Authorized Dealers/Resellers to facilitate ordering and delivery. The Contractor will be responsible for the performance of approved and authorized Representatives and Dealer/Resellers that it designates at time of bid submission and during the term of the contract. The State will not intercede in disputes between Contractor and its Representatives and/or its Authorized Dealers/Resellers.

It is the Contractors' (Manufacturer) responsibility to submit the required sales reports and administrative fee payments reflecting an accurate accounting of all activity with State users under this contract.

Please reference Attachment L and Section III, Clause 03-3090-3

Additionally,

- Prime Contractors shall be identified on all purchase orders, even if the purchase order is placed via an Authorized Dealer.
- Prime Contractors shall provide invoicing and receipt of payment from governmental entities. However, the contractor may assign monies due to the Authorized Dealer in accordance with R. 19-445.2180(A).
- Prime Contractors shall collaborate with Authorized Dealers for warranty claim resolution; and dealers shall be ultimately responsible for the warranty of items sold if the contractor is no longer in business.

Office Furniture Statewide Contract

- Authorized dealers will only be added twice/year. Manufacturers must request dealer additions on the appropriate form online in the same place as the original solicitation. ([Attachment L](#)) . Forms must be submitted to the Procurement Officer by the first Monday in March and September of each year.

Installation

Prime Contractors may request the addition of authorized dealers twice annually on the first Monday of March and September. Authorized dealers may not commit sales for any Prime Contractor until approval has been made by the Procurement Officer.

Installation of products requiring custom or complex fitting due to the nature of the product (such as a panel or rotary file system) and for which the cost is not included in the List Price, shall be quoted, ordered and billed separately.

Acceptance and approval of labor for installation of such products will be at the sole discretion of the Using Governmental Unit. Any resulting damages to the product or State property during the installation by the Contractor will be repaired at the Contractor's expense and according to the warranty requirements of this contract.

Rates provided in bid are hourly.

Design Services

Design services, if available to the Using Governmental Unit, may be accepted/approved at the sole discretion of the Using Governmental Unit. Any design service fee shall be quoted, ordered and billed separately. Rates provided in bid are hourly.

Order Cancellation

A South Carolina agency (or any other party who is authorized to purchase from this contract) may cancel an order without penalty if, up to five (5) days after receipt of the purchase order by the Contractor with whom the order was placed is given written notice by the Using Governmental Unit of cancellation.

The State will allow the Contractor with whom the order was placed, at their option, to charge a Using Governmental Unit a reasonable restocking fee for orders that are cancelled in excess of fourteen (14) days after receipt of the purchase order. Such restocking fee shall be approved by the Using Governmental Unit.

No "Quick ship" orders and/or special products may be cancelled after the order is scheduled for shipment.

The State will allow the Contractor with whom the order was placed, at their option, to charge a Using Governmental Unit a reasonable restocking fee for all custom orders that

No "Quick ship" orders and/or special products may be cancelled after the order is scheduled for shipment.

The State will allow the Contractor with whom the order was placed, at their option, to charge a Using Governmental Unit a reasonable restocking fee for all custom orders that are cancelled at any time after receipt of the purchase order. Such restocking fee shall be approved by the Using Governmental Unit prior to placing order.

Surcharges
