The Materials Management Office provides resources in support of the South Carolina Emergency Management Division in case of a statewide and/or nationwide emergency to provide and coordinate the provision of services, equipment and supplies to support expedient operations associated with a disaster or emergency; and for the approval and acquisition of equipment and supplies not available through normal purchasing channels and ordering timeframes.

Orders may also be placed by any state agency or entity for non-emergency purposes.

The Contractors shall supply polyester tarps with the following minimum specifications:

- Two sizes measuring 20' x 30' (+/- 6") and 20' x 40' (+/- 6")
- Minimum weave count of 10x10 denier range of 9,000 to 10,000, 4.05 ounce per square yard and 6 millimeter thickness.
- Waterproof, mildew resistant and rot proof.
- Rust resistant grommets (brass, bronze or other corrosion resistant material) on all edges with minimum/maximum placement from 18-36 inches apart.
- Available in Blue, Green or Black.

The Contractor shall wrap, ship and deliver products as follows:

- Wrap and package orders according to the quantity ordered of case(s), or pallet(s).
- Any packaged unit must be labeled and state the size, color, number of individual tarps, number of cases and overall package weight.
- Pallet(s) must be shrink wrapped or banded.
- Pallet(s) must be wrapped and packaged in order to meet the requirements of being air dropped by helicopter if emergency conditions mandate.
- Pallet(s) shall be suitable for handling by forklift or floor jack.
- Pallet(s) shall be delivered to any point that is accessible within the State of South Carolina.
