### **Protest Decision**

**Matter of:** Spartanburg Meat Processing Co., Inc and Robbins Sales Co., Inc.

**File No.:** 2024-120 & 2024-121

**Posting Date:** March 8, 2024

**Contracting Entity:** Department of Corrections

**Description:** Beans, Corn and Ground Turkey

#### **DIGEST**

The Chief Procurement Officer (CPO) denies the protest of Spartanburg Meat Processing Co., Inc. (Spartanburg) for nonresponsiveness to the solicitation's requirements. The CPO grants the protest of Robbins Sales Co., Inc (Robbins) where Robbins' bid was responsive to the solicitation's requirements. Protests are attached as Exhibits A and B.

#### **AUTHORITY**

The Chief Procurement Officer<sup>1</sup> (CPO) conducted an administrative review pursuant to S.C. Code Ann. §11-35-4210. This decision is based on materials in the procurement file and applicable law and precedents.

#### **BACKGROUND**

Invitation for Bids Issued	11/01/2023
Amendment 1 Issued	11/16/2023
Statement of Intent to Award Posted	12/18/2023

The facts pertinent to this decision are:

- On November 01, 2023, the Department of Corrections (SCDC) advertised for bids to purchase beans, corn, and ground turkey. The bidders were required to identify the brands they were bidding and were to include a manufacturer's cut sheet with size and nutritional information. Bidders were also required to "clearly and specifically identify the product being offered and enclose one copy of complete details, descriptive literature, illustration, catalog cuts and specifications with the bid to enable SCDC to determine if the product offered meets the requirements of the solicitation." [emphasis supplied]
- Amendment 1 answered vendor questions and reissued the solicitation with some
  modification including adding a requirement that the ground turkey must be USDA
  certified. As used hereinafter, reference to the solicitation is a reference to Amendment
  1.
- By the deadline for receipt of bids, SCDC received three bids for Line 1, Ground
  Turkey; however, the bids from Spartanburg and Robbins were deemed non-responsive
  on the grounds that they failed to submit information showing the product they were
  bidding was USDA certified ground turkey. [Exhibits C & D]
- On December 18, 2023, SCDC posted a notice of intent to award a contract to Clarks Trading Company (Clarks) for Line Item # 1 for ground turkey. [Exhibit E] The total potential value of this line item is \$739,200.
- On December 18, 2023, Spartanburg protested. On December 19, 2023, Robbins protested. Both protestants argued that they were the lower responsive and responsible

bidder, and both met the requirement that the meat bid comes from a USDA certified plant.

#### **DISCUSSION**

Both Spartanburg and Robbins protest the award to Clark's on the grounds that each was a lower responsive and responsible bidder and met all solicitation requirements.

The solicitation required the meat be USDA certified in two places, in answer to vendor question 5 and on the bidding schedule. In three places, the cover page, Section III Scope, and the bid schedule, the solicitation required bidders to "STATE BRAND YOU ARE OFFERING IN THE BIDDING SCHEDULE AND INCLUDE MANUFACTURERS CUT SHEET WITH SIZE AND NUTRITIONAL INFORMATION." (all caps in original). Finally, in the bidding schedule, the solicitation required bidders "TO SUBMIT A BRAND FOR REVIEW YOU MUST STATE THE BRAND NAME - YOU ALSO ARE REQUIRED TO INCLUDE THE MANUFACTURERS CUT SHEET WHICH INCLUDES SIZE AND NUTRITIONAL CONTENT - PACKAGING MUST BE AS STATED IN SOLICTATION." (all caps in original). None of these requirements to provide information required bidders to provide information showing the product they were bidding was USDA certified.

Part II of the solicitation also included the following clause:

DESCRIPTIVE LITERATURE -- REQUIRED (JAN 2006)

The bidder shall clearly and specifically identify the product being offered and enclose one copy of complete details, descriptive literature, illustration, catalog cuts and specifications with the bid to enable SCDC to determine if the product offered meets the requirements of the solicitation.

Your failure to provide descriptive literature may result in rejection of your offer. Failure to provide the literature results in a delay of processing the award. <sup>2</sup>

This clause required bidders to supply sufficient information for SCDC to determine that the product they were bidding met "the requirements of the solicitation." One of those requirements was that the product be USDA certified. Although the failure to include product literature is typically a minor informality under § 11-35-1520(13)(g), "if the data is needed to determine whether the offered items themselves conform to the solicitation's specifications, a bidder's failure to include appropriate data requires rejection of the bid as nonresponsive." *Matter of: Camar Corp.*, B-248485 (Comp. Gen. Aug. 31, 1992); *see also Matter of: Computer Science Corp.*, B-213134 (Comp. Gen. May 14, 1984) ("When descriptive literature is required by an IFB to be submitted with bids, the adequacy of the literature in showing compliance with the specifications is a matter of responsiveness. Where the literature does not show compliance, the bid must be rejected.").

Based on the forgoing, the CPO must determine whether the protestants provided sufficient information with their bids to "enable SCDC to determine if the product offered meets the requirements of the solicitation." For example, Spartanburg stated on its bid that it was providing meat produced by Butterball and included information from Butterball regarding its product. However, nothing in the provided information states that the meat is USDA certified. This is not the end of the matter though. If the fact that the meat was produced by Butterball was sufficient to "enable SCDC to determine if the product offered meets the requirements of the solicitation," then Spartanburg is responsive. The same is true for Robbins. In fact, Robbins provided more information. Robbins identified its producer as Kingsland Prime Meats (Kingsland) and the information provided included Kingsland's plant number.

<sup>&</sup>lt;sup>2</sup> This clause when considered with the earlier cited clauses creates an ambiguity. However, the ambiguity is patent and, per the solicitation, the bidder "assumes responsibility for any patent ambiguity in the Solicitation that Offeror does not bring to the State's attention." SCDC could have avoided these protests had it been clearer about what information it expected bidders to provide to enable it to determine the product complied with the specifications.

In the United States, the slaughter of animals and production of meat from their carcasses for commercial sale for human consumption is governed by the Federal Meat Inspection Act (FMIA). 21 USC 601, et seq. Robbins argues that "[a]ll domestic meat processors are USDA certified/inspected, the direct proof of which is their USDA Plant Number." Spartanburg likewise argues that "[alll meat producers for commercial use must be USDA certified. Indeed, under the FMIA, all domestic producers must be USDA certified and their meat products sold for human consumption must bear a seal of USDA certification. Even producers who process meat products to be sold only within a State, a situation that does not apply here, are subject to the federal inspection unless they are regulated under a State Meat and Poultry Inspection program certified by USDA. 21 USC 661. The USDA publishes an FSIS Meat, Poultry and Egg Product *Inspection Directory -By Est. Name.* Per the USDA this directory "is a listing of establishments that produce meat, poultry, and/or egg products regulated by USDA's Food Safety and Inspection Service (FSIS) pursuant to the Federal Meat Inspection Act, the Poultry Products Inspection Act, and the Egg Products Inspection Act." See data.gov, an official website of the United States Government – https://catalog.data.gov/dataset/fsis-meat-poultry-and-egginspection-directory-by-establishment-number. Both Butterball and Kingsland are listed in this directory and the Kingsland plant number in the information provided by Robbins with its bid matches the plant number in the directory. According to Robbins, SCDC could have easily used the information it provided to confirm that the product it was offering was produced in a USDA certified plant and therefore, is USDA certified.<sup>3</sup> The CPO agrees. Therefore, by including the plant number, Robbins included sufficient information on the face of its bid to determine its responsiveness.

Spartanburg, however, failed to provide enough information with its bid to determine its responsiveness. If Butterball is also an importer of meat products for sale in the United States, those meats may not be USDA certified but certified under the regime of the country of origin.

<sup>&</sup>lt;sup>3</sup> Indeed, in response to the protests SCDC states "[w]hile meats domestically produced must be processed in a plant that is USDA certified or inspected this is not so for foreign entities." Thus, SCDC acknowledges that if the product is produced in a United States plant it is USDA certified. The awardee also placed great emphasis on the importance of the Plant Number for establishing USDA certification in its bid. [Exhibits F and G]

While each of the countries have been certified by USDA as having an inspection regime equivalent to that in the United States, these meats are not USDA certified.<sup>4</sup> While the CPO can speculate, she cannot conclusively determine based on the producer's name alone that Spartanburg's product is USDA certified. Had Spartanburg also provided one or more Butterball Plant Numbers matching the Plant Numbers on the USDA list of producers, the result would be

different.

For the reasons stated above, the CPO denies the protest of Spartanburg and grants the protest of Robbins. The award is cancelled, and the procurement is remanded to The Department of Corrections to process in accordance with the Procurement Code.

#### STATEMENT OF RIGHT TO FURTHER ADMINISTRATIVE REVIEW

Protest Appeal Notice (Revised July 2023)

The South Carolina Procurement Code, in Section 11-35-4210, subsection 6, states:

(6) Finality of Decision. A decision pursuant to subsection (4) is final and conclusive, unless fraudulent or unless a person adversely affected by the decision requests a further administrative review by the Procurement Review Panel pursuant to Section 11-35-4410(1) within ten days of posting of the decision in accordance with subsection (5). The request for review must be directed to the appropriate chief procurement officer, who shall forward the request to the panel or to the Procurement Review Panel, and must be in writing, setting forth the reasons for disagreement with the decision of the appropriate chief procurement officer. The person also may request a hearing before the Procurement Review Panel. The appropriate chief procurement officer and an affected governmental body shall have the opportunity to participate fully in a later review or appeal, administrative or judicial.

[The Request for Filing Fee Waiver form is attached to this Decision.] If the filing fee is not waived, the party must pay the filing fee within fifteen days of the date of receipt of the order denying waiver of the filing fee. Requests for administrative review will not be accepted unless accompanied by the filing fee or a completed Request for Filing Fee Waiver form at the time of filing." PLEASE MAKE YOUR CHECK PAYABLE TO THE "SC PROCUREMENT REVIEW PANEL."

LEGAL REPRESENTATION: In order to prosecute an appeal before the Panel, business entities organized and registered as corporations, limited liability companies, and limited partnerships must be represented by a lawyer. Failure to obtain counsel will result in dismissal of your appeal. *Protest of Lighting Services*, Case No. 2002-10 (Proc. Rev. Panel Nov. 6, 2002) and *Protest of The Kardon Corporation*, Case No. 2002-13 (Proc. Rev. Panel Jan. 31, 2003); and *Protest of PC&C Enterprises*, *LLC*, Case No. 2012-1 (Proc. Rev. Panel April 2, 2012). However, individuals and those operating as an individual doing business under a trade name may proceed without counsel, if desired.

Please let this letter serve as an official notice of protest for Sol# 5400026161. There was a requirement listed on the bid for Line Number 0001 stating, "Must be USDA certified". When directly applied to Meat this requirement by definition means that the product must be produced within a plant that is USDA certified/inspected and thus has a USDA Plant Number. All commercial domestic meat processers are USDA certified/inspected, the direct proof of which is their USDA Plant Number. If they did not have a USDA plant number they would be operating illegally. All product that is product within a plant that is USDA certified/inspected will have a USDA inspection seal on the product and in that seal will be their Plant Number listed on it. Therefore, if you have a bid requirement where product, "Must be USDA certified" then it's fair to expect your agency to have complete understanding of what it is you're actually requesting and what information/data you would need to confirm that. The specification sheet submitted with our bid listed our suppliers plant number as 5067 which is their USDA Plant Number. This is the same plant number that will be on the USDA inspection seal.

As explained above if a producer has a USDA plant number and we provide a specification sheet with the bid that has the plant number listed in the header then by definition it shows and proves that the product we are offering meets your bids requirement that product, "Must be USDA certified". If everything a domestic commercial meat processor produces has to have a USDA Shield on it then logically any case we would supply that is produced and or delivered to your as a result of the contract will have the USDA Shield on it. That alone is proof and confirmation that our item meets specifications as submitted. There should be no need for any additional clarification required from your agency or us to determine if our item meets specifications. It's imperative to have an understanding and awareness of the commodity being procured. In this instance we believe the agency has demonstrated a lack of understanding of what your requirement, "Must be USDA certified" actually meant or how it can be affirmed.

This will result in a contract that is unfavorable to your agency and tax payers. We would point out that our bid for this product was \$1.38/lb, and Clarks Trading Company who you Intend to Award bid \$1.68/lb for the same product. There is a difference of \$132,000.00 on the total contract value i.e. your agencies/public funds expenditure. This is a very large sum of money and we believe should be treated very intentionally and with due diligence. If we have clearly demonstrated and proved that our bid as submitted including the spec sheet listing the USDA Plant Number conformed and met your bids

requirement then we believe there is rightful grounds for reversal/amendment of the Intent to Award as provided to Clarks Trading Company to us Robbins Sales Company Inc. Any justification to ignore or dismiss that the product we bid meets your specification and will save your agencies/public funds expenditure by \$132,000.00 would be unfavorable and disadvantageous to the constituents who pay into public funds. This is why a protest is appropriate in this situation.

There are many resources that can be referenced to corroborate what I have said in this letter including, the attached, "FSIS Meat, Poultry and Egg Product Inspection Directory" which lists all it clearly shows that plant M5067+P5057 are USDA approved/inspected for meat processing, poultry processing. Additionally, you will see the company name tied to these plant numbers is, "Kingsland Meat Distributors Inc." located at 10 Squirrel wood Road Woodland Park, NJ 07424. This matches the company name on our spec and the address as listed.

(Attachment #8) In the United States, FSIS regulates meat, poultry and egg products. However, all remaining foods are regulated by the Department of Health and Human Service's Food and Drug Administration (FDA). As such, there are different import requirements for different types of imported food.

SCDC has previously experienced a vendor shipping meat to SCDC that was not certified thru the USDA from Mexico.

This question being asked raised a red flag questioning could someone again possibly try to supply meat illegally.
