DIGEST

The Chief Procurement Officer denies the protest of FSIOffice (FSI), as it raises a matter of contract administration and fails to state a proper ground of protest. FSI's protest is attached as Exhibit A.

AUTHORITY

The Chief Procurement Officer¹ (CPO) conducted an administrative review pursuant to S.C. Code Ann. §11-35-4210. This decision is based on materials in the procurement file and applicable law and precedents.

BACKGROUND

Invitation for Bids Issued	09/09/2024
Amendment 1 Issued	10/09/2024
Statement of Intent to Award Posted	11/20/2024

The facts pertinent to this decision are:

- On September 09, 2024, the Division of Procurement Services (DPS) advertised for bids to establish a source for remanufactured toner cartridges compatible with Dell (Lot 1) and HP (Lot 2) printers. The bidders were required to adhere to multiple standards as noted in the solicitation:
 - Bidders were required to “furnish remanufactured toner cartridges that have been fully remanufactured to specifications equal to or exceeding standards of cartridge quality and performance cartridge as set by original equipment manufacturers (OEMs) and the remanufactured toner cartridge industry. Toner cartridges furnished to these specifications shall meet or exceed the latest remanufactured toner cartridge standards, including but not limited to the guidelines adopted by the Standardized Test Methods Committee (STMC), the American Society for Testing and Materials (ASTM) and the International Safe Transit Association (ISTA), including the F 2036 Standards and ISTA – Integrity Procedure 1A Standards (ISTA 1A). This list is not comprehensive; Contractor must at all times remain in compliance with these and other industry standards. Contractor shall at all times throughout the duration of this contract remain certified by the STMC for the remanufacturing of toner cartridges.”
- Amendment 1 answered supplier questions and reissued the solicitation with some modification. As used hereinafter, reference to the solicitation is a reference to Amendment 1. [Exhibit B]
- Bidders were advised in the solicitation and the Bidding Schedule that failure to offer on all line items within a lot would make the offer non-responsive for that lot.
- By the deadline for receipt of bids, DPS received fifteen bids for both lots; however, one bid was deemed non-responsive in its entirety on the grounds that they failed to submit

pricing on all items within the Lots. Four additional bids were deemed non-responsive for Lot 2 based on the same grounds. [Exhibit C]

- On November 20, 2024, DPS posted a notice of intent to award a contract to Academic Supplier and The Office Pal, Inc. (Office Pal). Academic Supplier was the awardee for Lot 2 for HP Remanufactured Toner Cartridges. The evaluated amount of this lot was \$695,100. Office Pal was the awardee for Lot 1 for Dell Remanufactured Toner Cartridges. The evaluated amount of this lot was \$92,000. [Exhibit D]
- On November 25, 2024, FSI submitted an Intent to Protest. On December 04, 2024, FSI perfected its protest of both Academic Supplier and Office Pal's intended awards. FSI argued that the "aggressively low pricing" offered by Academic Supplier and Office Pal was indicative of offering a product that was not a true remanufactured product in compliance with the solicitation.

DISCUSSION

FSI protests that Office Pal and Academic Supplier have bid "aggressively low prices" and questions whether they will be able to perform the contract at these prices. According to FSI:

Upon review of the pricing submitted by the awardees, we have serious concerns regarding their ability to provide products that comply with the specifications outlined in the Scope of Work. The pricing submitted is significantly lower—approximately half the cost of our bid—raising questions about the nature of the products being offered.

We believe these aggressively low prices suggest the use of alternative compatible cartridges, such as low-cost, single-use substitutes. Such products would fail to meet the definition of 'true remanufactured cartridges' and undermine the State of South Carolina's sustainability goals, which are integral to the Scope of Work.

(Ex. A, FSI Protest).


FSI's protest, however, merely speculates that Office Pal and Academic Supplier will be unable to perform. The Procurement Review Panel has consistently held that a protest based on grounds that an awardee "cannot perform the contract at the price bid" does not state a proper ground of protest. *Appeal by VetPride Serv., Inc.*, Case No. 2018-5. FSI's protest simply "raises a matter of contract administration based on speculation that [the awardee] may violate the contract." *Id.*

Here, by signing their bids, both Office Pal and Academic Supplier agreed to be bound by all the IFB's requirements, including that the remanufactured toner cartridges will meet or exceed the standards stated in the IFB. Accordingly, FSI's protest fails to state a proper ground of protest.

Upon receipt of the protest, as a means of due diligence, the CPO did reach out to both Office Pal and Academic Supplier to confirm the products being offered adhere to the standards referenced within the solicitation document. Each company confirmed their compliance and validated their pricing as being firm and accurate.

DECISION

For the reasons stated above, the CPO denies FSI's protest.

STATEMENT OF RIGHT TO FURTHER ADMINISTRATIVE REVIEW

Protest Appeal Notice (Revised July 2025)

The South Carolina Procurement Code, in Section 11-35-4210, subsection 6, states:

(6) Finality of Decision. A decision pursuant to subsection (4) is final and conclusive, unless fraudulent or unless a person adversely affected by the decision requests a further administrative review by the Procurement Review Panel pursuant to Section 11-35-4410(1) within ten days of posting of the decision in accordance with subsection (5). The request for review must be directed to the appropriate chief procurement officer, who shall forward the request to the panel or to the Procurement Review Panel, and must be in writing, setting forth the reasons for disagreement with the decision of the appropriate chief procurement officer. The person also may request a hearing before the Procurement Review Panel. The appropriate chief procurement officer and an affected governmental body shall have the opportunity to participate fully in a later review or appeal, administrative or judicial.

The panel is authorized to charge the party requesting an administrative review under the South Carolina Code Sections 11-35-4210(6), 11-35-4220(5), 11-35-4230(6) and/or 11-35-4410...Withdrawal of an appeal will result in the filing fee being forfeited to the panel. If a party desiring to file an appeal is unable to pay the filing fee because of financial hardship, the party shall submit a completed Request for Filing Fee Waiver form at the same time the request for review is filed. *[The Request for Filing Fee Waiver form is attached to this Decision.]* If the filing fee is not waived, the party must pay the filing fee within fifteen days of the date of receipt of the order denying waiver of the filing fee. Requests for administrative review will not be accepted unless accompanied by the filing fee or a completed Request for Filing Fee Waiver form at the time of filing." PLEASE MAKE YOUR CHECK PAYABLE TO THE "SC PROCUREMENT REVIEW PANEL."

LEGAL REPRESENTATION: In order to prosecute an appeal before the Panel, business entities organized and registered as corporations, limited liability companies, and limited partnerships must be represented by a lawyer. Failure to obtain counsel will result in dismissal of your appeal. *Protest of Lighting Services*, Case No. 2002-10 (Proc. Rev. Panel Nov. 6, 2002) and *Protest of The Kardon Corporation*, Case No. 2002-13 (Proc. Rev. Panel Jan. 31, 2003); and *Protest of PC&C SubscribeITs, LLC*, Case No. 2012-1 (Proc. Rev. Panel April 2, 2012). However, individuals and those operating as an individual doing business under a trade name may proceed without counsel, if desired.

Subject: Protest of Award to The Office Pal and Academic Suppliers

To Whom It May Concern:

FSIoffice (Forms & Supply, Inc.) formally protests the State of South Carolina's award of Solicitation 5400027356 for remanufactured Dell and HP toner cartridges to The Office Pal and Academic Suppliers.

Background:

The Invitation for Bid (IFB), issued on September 9, 2024, requires the awarded contractor(s) to supply remanufactured HP and Dell toner cartridges that meet stringent quality and performance standards. The IFB's Scope of Work, outlined in Section III, specifies that:

"Contractor shall furnish remanufactured toner cartridges that have been fully remanufactured to specifications equal to or exceeding standards of cartridge quality and performance as set by original equipment manufacturers (OEMs) and the remanufactured toner cartridge industry. Toner cartridges shall meet or exceed the latest industry standards, including but not limited to guidelines from the Standardized Test Methods Committee (STMC), the American Society for Testing and Materials (ASTM), and the International Safe Transit Association (ISTA), including F2036 Standards and ISTA 1A Standards. Contractors must remain in compliance with these standards and be STMC certified for remanufacturing toner cartridges throughout the contract duration."

Protest Basis:

Upon review of the pricing submitted by the awardees, we have serious concerns regarding their ability to provide products that comply with the specifications outlined in the Scope of Work. The pricing submitted is significantly lower—approximately half the cost of our bid—raising questions about the nature of the products being offered.

We believe these aggressively low prices suggest the use of alternative compatible cartridges, such as low-cost, single-use substitutes. Such products would fail to meet the definition of "true remanufactured cartridges" and undermine the State of South Carolina's sustainability goals, which are integral to the Scope of Work.

Requests for Clarification and Accountability:

1. **Transparency:** We respectfully request that the source of the awarded bidders' products be disclosed.
2. **Compliance:** We urge the State to ensure accountability during the contract period by verifying that the products supplied meet the defined specifications for remanufactured cartridges, including adherence to STMC, ASTM, and ISTA standards.

FSIoffice (Forms & Supply, Inc.) Manufacturer Credentials:

Our manufacturer, Clover Imaging Group, is the world's largest remanufacturing company. Clover meets all the requirements outlined in the Scope of Work and operates a 560,000-square-foot facility in North America. Clover collects millions of spent OEM cartridges each month and remanufactures them to meet or exceed all industry standards specified in the IFB.

We invite the State to tour Clover's facility to witness our compliance firsthand. In contrast, we request information on the awardees' manufacturing facilities, collection procedures, and remanufacturing processes to ensure they can meet the same rigorous standards.


We appreciate your attention to this matter and trust that the State of South Carolina will uphold the integrity of this procurement process.

I. SCOPE OF SOLICITATION

ACQUIRE SERVICES and SUPPLIES / EQUIPMENT (MODIFY)

The purpose of this solicitation is to establish a source for remanufactured toner cartridges compatible with Dell (Lot 1) and HP (Lot 2) printers and in conformance with the specifications listed herein. Each Lot will be awarded to only one Offeror. Lot 1 and Lot 2 may be awarded to the same Offeror.

Offerors must be capable of supplying all categories of products and individual products, and all related services, included within any Lot for which Offeror submits an offer. The contract(s) will be for statewide use among a customer base that includes state agencies, higher-education entities, local governments, and other political subdivisions of South Carolina.

MAXIMUM CONTRACT PERIOD - ESTIMATED (MODIFIED)

The estimated start date for this contract is **01/07/2025** and the estimated end date is **01/06/2030**. The initial term of the contract is for one (1) year with the potential for four (4) optional one-year terms. **Dates provided are estimates only.** Any resulting contract will begin on the date specified in the notice of award. See clause entitled “Term of Contract – Effective Date/Initial Contract Period”.

III. SCOPE OF WORK/SPECIFICATIONS

The specifications contained herein shall apply equally to Lot 1 (remanufactured Dell toner cartridges) and Lot 2 (remanufactured HP toner cartridges).

1. Cartridge Remanufacturing Process

- a. Contractor shall furnish remanufactured toner cartridges that have been fully remanufactured to specifications equal to or exceeding standards of cartridge quality and performance cartridge as set by original equipment manufacturers (OEMs) and the remanufactured toner cartridge industry. Toner cartridges furnished to these specifications shall meet or exceed the latest remanufactured toner cartridge standards, including but not limited to the guidelines adopted by the Standardized Test Methods Committee (STMC), the American Society for Testing and Materials (ASTM) and the International Safe Transit Association (ISTA), including the F 2036 Standards and ISTA – Integrity Procedure 1A Standards (ISTA 1A). This list is not comprehensive; Contractor must at all times remain in compliance with these and other industry standards. Contractor shall at all times throughout the duration of this contract remain certified by the STMC for the remanufacturing of toner cartridges. An overview of other minimum requirements for remanufactured toner cartridges are listed below.
- b. The term “remanufactured” is defined as a cartridge which has been completely disassembled, cleaned, lubricated, and replaced with a new long-life aftermarket photoconductor drum on every cycle. All internal and external parts, including but not limited to cleaning blade, primary charge roller, corona wire assembly, developer blade, developer (mag) roller, recover blade, pins, clips, seals (utilizing an OEM-type sealing system to seal the toner housing section in the cartridges), felts, brushing springs, and foams, are to be properly refurbished or replaced with new parts equal to or exceeding the original parts. In addition, fully functional OEM-compatible chips must be installed for those cartridges requiring chips. The fuser wand work felt must be removed from the fixing roller cleaner and a new, oil-treated felt strip, equivalent in all aspects to the original equipment manufacturer felt, must be installed. The fuser wand and cotton swab must be completely sealed in plastic packaging material to preserve and protect the parts.
- c. The cartridge remanufacturing process shall include, at a minimum:
 - i. Completion of an assessment to determine if the toner cartridge is capable of being remanufactured.
 - ii. Complete disassembly of toner cartridge to thoroughly clean and check all internal and external components, including but not limited to, cleaning blade, primary charge roller, corona wire assembly, developer blade, developer (mag) roller, recover blade, pins, clips, seals (must use OEM-type sealing system to seal the toner housing section in the cartridges), felts, brushing springs, and foams. Each component, whether or not listed herein, is to be properly refurbished or replaced with new component of equal or greater quality and performance. Worn, damaged, or end-of-life-cycle components shall be replaced.
 - iii. Replacement of the original OEM drum with a new drum (which may include an extended life-drum). If the returned toner cartridge is equipped with an extended-life drum, Contractor shall inspect it, clean it, or replace it with a new extended-life drum or new after-market drum.
 - iv. Replacement of all seals with an OEM-type heat seal, card seal, or pressure-sensitive seal.
 - v. Replacement of the primary charge roller (PCR) with a re-coated or new PCR.
 - vi. Replacement of wiper blade that shall meet OEM specifications, or the latest remanufactured toner cartridge industry standards adopted by the STMC, or the latest guidelines adopted by ASTM for remanufactured toner cartridges.
 - vii. Replacement of any parts not meeting OEM specifications, or the latest remanufactured toner cartridge industry standards adopted by the STMC, or the latest guidelines adopted by ASTM for remanufactured toner cartridges.

- viii. Filling of toner cartridge meeting OEM specifications or the latest remanufactured toner cartridge industry standards adopted by the STMC or the latest guidelines adopted by ASTM for remanufactured toner cartridges.
- ix. Chemically cleaning or replacing the corona wire assembly (where applicable).
- x. The hopper shall be filled to capacity with new toner meeting or exceeding OEM standards.
- xi. One fuser wand (where applicable) with high temperature-resistant felt wiper and one cotton swab shall be provided with each toner cartridge.
- xii. A toner hopper seal/separator meeting or exceeding OEM standards shall be inserted to prevent spillage of toner during shipping.

2. Cartridge Packaging

The Cartridge packaging process shall include, at a minimum, the following requirements:

- a. Contractor shall clearly label each toner cartridge with the manufacturer's (and, if applicable, supplier's) name and cartridge model number.
- b. Each toner cartridge shall be packaged in an antistatic moisture-proof bag and either heat-sealed or zip-locked in a manner meeting or exceeding OEM standards. The cartridge shall then be placed in a protective cradle prior to being packaged in an external carton.
- c. Notwithstanding any other requirements herein, the external carton and packaging of the toner cartridge must be sufficient to protect the cartridge from damage during shipping.
- d. Packaging for the toner cartridges shall be constructed to permit users to re-package spent cartridges for return to Contractor. All corrugated packaging should comprise, at a minimum, 35% post-consumer recycled content and provide certification from the carton manufacturer/supplier verifying the actual percentage of recycled content.
- e. The external carton, or the shipping invoice included therein, shall clearly identify toner cartridge type (brand name, supplier if applicable, and make and model), Contractor's name, address, email address, telephone number, State Contract number, and the purchase order number. All cartridge boxes, or the shipping invoices included therein, will also bear the date of remanufacture and use-by date for shelf life and inventory purposes.
- f. Each cartridge shall be delivered with complete instructions included for installation as well as guidance on maintenance of the cartridges to optimize the performance and useful life to the cartridge.

3. Defective Cartridges

- a. Contractor must repair customer printers using an OEM-certified person(s) to repair printers if the remanufactured toner cartridge damages the printer.
- b. If Contractor encounters, or receives notification from customer of, a defective remanufactured toner cartridge, Contractor shall discuss the issue with customer and correct any problems and, if problem remains unresolved one hour after notification, shall visit the location of the individual customer utilizing the remanufactured toner cartridge in person within 24 hours after such notification.
- c. All cartridges shall be guaranteed to perform to the OEM's specifications. The cartridge shall equal or exceed the yield of the OEM's specification. Any cartridge found to be defective shall be replaced, free of charge, regardless of the amount of toner remaining in the cartridge. Defective cartridges shall be replaced, or alternatively payment refunded at the customer's discretion, within five (5) calendar days after Contractor is notified.
- d. If problems occur with printers due to Contractor's defective remanufactured toner cartridge(s):

- i. The OEM-certified individual must arrive onsite within 24 hours after the trouble call has been received/placed.
 - ii. Contractor shall cover all costs for the repair and/or replacement of printers, cartridges, and other accessories to the extent that they were damaged by a defective toner cartridge. Such costs include, but may not be limited to, all service calls, printer repairs, parts, and toner cartridge replacements. If cartridge replacement is necessitated, Contractor will replace the defective remanufactured laser toner cartridge with a satisfactory remanufactured laser toner cartridge or new OEM-brand toner cartridge.
- e. All defective toner cartridges will be returned to Contractor at Contractor's expense.
 - f. If Contractor is notified of a defective cartridge, Contractor shall supply pre-paid mailing labels or, if expedited service is necessary, shall pick up the defective cartridges at the location of the original toner cartridge delivery.
 - g. If continued uncorrected problems with a particular model occur, or if there are page yields consistently below OEM standards or approved manufactured toner cartridge industry standards, the State may remove the cartridge model from the contract at its sole discretion.
 - h. If the toner cartridge defect rate exceeds three (3%) percent of all cartridges utilized within any six-month period, the State reserves the right to terminate the contract.

4. Restocking Fee

- a. If unopened product(s) is returned to contractor within thirty (30) days after acceptance, such returned product(s) will be accepted by Contractor, and no restocking fee will be charged to the customer.

Contractor consents that any papers, notices, or process necessary or proper for the initiation or continuation of any disputes, claims, or controversies relating to the Agreement; for any court action in connection therewith; or for the entry of judgment on any award made, may be served on Contractor by certified mail (return receipt requested) addressed to Contractor at the address provided as the Notice Address on Page Two or by personal service or by any other manner that is permitted by law, in or outside South Carolina. EQUAL OPPORTUNITY (JAN 2006)

Contractor is referred to and shall comply with all applicable provisions, if any, of Title 41, Part 60 of the Code of Federal Regulations, including but not limited to Sections 60-1.4, 60-4.2, 60-4.3, 60-250.5(a), and 60-741.5(a), which are hereby incorporated by reference. [07-7A030-1]

FALSE CLAIMS (JAN 2006)

(A) After award, any notices shall be in writing and shall be deemed duly given (1) upon actual delivery, if delivery is by hand, (2) upon receipt by the transmitting party of automated confirmation or answer back from the recipient's device if delivery is by telex, telegram, facsimile, or electronic mail, or (3) upon deposit into the United States mail, if postage is prepaid, a return receipt is requested, and either registered or certified mail is used. (B) Notice to contractor shall be to the address identified as the Notice Address on Page Two. Notice to the state shall be to the Procurement Officer's address on the Cover Page. Either party may designate a different address for notice by giving notice in accordance with this paragraph. [07-7A050-1]

OPEN TRADE (JUN 2015)

ORGANIZATIONAL CONFLICT OF INTEREST (APR 2023)

- (a) The Contractor agrees to immediately advise the Procurement Officer if an actual or potential organizational conflict of interest is discovered after award, and to make a full written disclosure promptly thereafter to the Procurement Officer. This disclosure shall include a description of actions which the Contractor has taken or proposes to take, after consultation with the Procurement Officer, to avoid, mitigate, or neutralize the actual or potential conflict.
- (b) The State may terminate this contract for convenience, in whole or in part, if it deems such termination necessary to avoid an organizational conflict of interest. Contractor's failure to include an appropriate termination for convenience clause in any subcontract shall not increase the obligation of the State beyond what it would have been if the subcontract had contained such a clause.
- (c) The disclosure required by paragraph (a) of this provision is a material obligation of the contract. If the Contractor knew or should have known of an organizational conflict of interest prior to award, or discovers an actual or potential conflict after award, and does not disclose, or misrepresents, relevant information to the Procurement Officer, the State may terminate the contract for default. PAYMENT and INTEREST (FEB 2021)

The State shall pay the Contractor, after the submission of proper invoices or vouchers, the prices stipulated in this contract for supplies delivered and accepted or services rendered and accepted, less any deductions provided in this contract. Unless otherwise specified herein, including the purchase order, payment shall not be made on partial deliveries accepted by the Government. (b) Unless otherwise provided herein, including the purchase order, payment will be made by electronic funds transfer (EFT). See clause titled " EFT Information." (c) Notwithstanding any other provision, payment shall be made in accordance with S.C. Code Section 11-35-45, or Chapter 6 of Title 29 (real property improvements) when applicable, which provides the Contractor's exclusive means of recovering any type of interest from the Owner. Contractor waives imposition of an interest penalty unless the invoice submitted specifies that the late penalty is applicable. Except as set forth in this paragraph, the State shall not be liable for the payment of interest on any debt or claim arising out of or related to this contract for any reason. (d) Amounts due to the State shall bear interest at the rate of interest established by the South Carolina Comptroller General pursuant to Section 11-35-45 ("an amount not to exceed fifteen percent each year"), as amended, unless otherwise required by Section 29-6-30. (e) Any other basis for interest, including but not limited to general (pre- and post-judgment) or specific interest statutes, including S.C. Code Ann. Section 34-31-20, are expressly waived by both parties. If a court, despite this agreement and waiver, requires that interest be paid on any debt by either party other than as provided by items (c) and (d) above, the parties further agree that the applicable interest rate for any given calendar year shall be the lowest prime rate as listed in the first edition of the Wall Street Journal published for each year, applied as simple interest without compounding. (f) The State shall have all of its common law, equitable and statutory rights of set-

PUBLICITY (JAN 2006)

Contractor shall not publish any comments or quotes by State employees or include the State in either news releases or a published list of customers, without the prior written approval of the Procurement Officer. [07-7A060-1]

PURCHASE ORDERS (JAN 2006)

Contractor shall not perform any work prior to the receipt of a purchase order from the using governmental unit. The using governmental unit shall order any supplies or services to be furnished under this contract by issuing a purchase order. Purchase orders may be used to elect any options available under this contract, e.g., quantity, item, delivery date, payment method, but are subject to all terms and conditions of this contract. SURVIVAL OF OBLIGATIONS (JAN 2006)

The Parties' rights and obligations which, by their nature, would continue beyond the termination, cancellation, rejection, or expiration of this contract shall survive such termination, cancellation, rejection, or expiration, including, but not limited to, the rights and obligations created by the following clauses: Indemnification - Third Party Claims, Intellectual Property Indemnification, and any provisions regarding warranty or audit. TAXES (JAN 2006)

Any tax the contractor may be required to collect or pay upon the sale, use or delivery of the products shall be paid by the State, and such sums shall be due and payable to the contractor upon acceptance. Any personal property taxes levied after delivery shall be paid by the State. It shall be solely the State's obligation, after payment to contractor, to challenge the applicability of any tax by negotiation with, or action against, the taxing authority. In the event of a cancellation pursuant to this paragraph, contractor will be reimbursed the resulting unamortized, reasonably incurred, nonrecurring costs. THIRD PARTY BENEFICIARY (JAN 2006)

This Contract is made solely and specifically among and for the benefit of the parties hereto, and their respective successors and assigns, and no other person will have any rights, interest, or claims hereunder or be entitled to any benefits under or on account of this Contract as a third party beneficiary or otherwise. WAIVER (JAN 2006)

The State does not waive any prior or subsequent breach of the terms of the Contract by making payments on the Contract, by failing to terminate the Contract for lack of performance, or by failing to strictly or promptly insist upon any term of the Contract. Only the Procurement Officer has actual authority to waive any of the State's rights under this Contract. Any waiver must be in writing. [07-7

VII. TERMS AND CONDITIONS -- B. SPECIAL

CHANGES (JAN 2006)

(1) Contract Modification. By a written order, at any time, and without notice to any surety, the Procurement Officer may, subject to all appropriate adjustments, make changes within the general scope of this contract in any one or more of the following:

- (a) drawings, designs, or specifications, if the supplies to be furnished are to be specially manufactured for the [State] in accordance therewith;
- (b) method of shipment or packing;
- (c) place of delivery;
- (d) description of services to be performed;
- (e) time of performance (i.e., hours of the day, days of the week, etc.); or,
- (f) place of performance of the services. Subparagraphs (a) to (c) apply only if supplies are furnished under this contract. Subparagraphs (d) to (f) apply only if services are performed under this contract.

(2) Adjustments of Price or Time for Performance. If any such change increases or decreases the contractor's cost of, or the time required for, performance of any part of the work under this contract, whether or not changed by the order, an adjustment shall be made in the contract price, the delivery schedule, or both, and the contract modified in writing accordingly. Any adjustment in contract price made pursuant to this clause shall be determined in accordance with the Price Adjustment Clause of this contract. Failure of the parties to agree to an adjustment shall not excuse the contractor from proceeding with the contract as changed, provided that the State promptly and duly make such provisional adjustments in payment or time for performance as may be reasonable. By proceeding with the work, the contractor shall not be deemed to have prejudiced any claim for additional compensation, or an extension of time for completion.

(3) Time Period for Claim. Within 30 days after receipt of a written contract modification under Paragraph (1) of this clause, unless such period is extended by the Procurement Officer in writing, the contractor shall file notice of intent to assert a claim for an adjustment. Later notification shall not bar the contractor's claim unless the State is prejudiced by the delay in notification.

(4) Claim Barred After Final Payment. No claim by the contractor for an adjustment hereunder shall be allowed if notice is not given prior to final payment under this contract.

COMPLIANCE WITH LAWS (JAN 2006)

During the term of the contract, contractor shall comply with all applicable provisions of laws, codes, ordinances, rules, regulations, and tariffs. [07-7B035-1]

CONFERENCE -- PRE-PERFORMANCE (JAN 2006)

Unless waived by the Procurement Officer, a pre-performance conference between the contractor, state and Procurement Officer shall be held at a location selected by the state within five (5) days after final award, and prior to commencement of work under the contract. The responsibilities of all parties involved will be discussed to assure a meeting of the minds of all concerned. The successful contractor or his duly authorized representative shall be required to attend at contractor's expense. [07-7B040-1]

CONTRACT LIMITATIONS (JAN 2006)

No sales may be made pursuant to this contract for any item or service that is not expressly listed. No sales may be made

pursuant to this contract after expiration of this contract. Violation of this provision may result in termination of this contract and may subject contractor to suspension or debarment. [07-7B045-1]

CONTRACTOR PERSONNEL (JAN 2006)

The Contractor shall enforce strict discipline and good order among the Contractor's employees and other persons carrying out the Contract. The Contractor shall not permit employment of unfit persons or persons not skilled in tasks assigned to them. [07-7B060-1]

CONTRACTOR'S OBLIGATION -- GENERAL (JAN 2006)

The contractor shall provide and pay for all materials, tools, equipment, labor and professional and non-professional services, and shall perform all other acts and supply all other things necessary, to fully and properly perform and complete the work. The contractor must act as the prime contractor and assume full responsibility for any subcontractor's performance. The contractor will be considered the sole point of contact with regard to all situations, including payment of all charges and the meeting of all other requirements. [07-7B065-1]

DEFAULT (JAN 2006)

(a) (1) The State may, subject to paragraphs (c) and (d) of this clause, by written notice of default to the Contractor, terminate this contract in whole or in part if the Contractor fails to:

- (i) Deliver the supplies or to perform the services within the time specified in this contract or any extension;
- (ii) Make progress, so as to endanger performance of this contract (but see paragraph (a)(2) of this clause); or
- (iii) Perform any of the other material provisions of this contract (but see paragraph (a)(2) of this clause).

(2) The State's right to terminate this contract under subdivisions (a)(1)(ii) and (1)(iii) of this clause, may be exercised if the Contractor does not cure such failure within 10 days (or more if authorized in writing by the Procurement Officer) after receipt of the notice from the Procurement Officer specifying the failure.

(b) If the State terminates this contract in whole or in part, it may acquire, under the terms and in the manner the Procurement Officer considers appropriate, supplies or services similar to those terminated, and the Contractor will be liable to the State for any excess costs for those supplies or services. However, the Contractor shall continue the work not terminated.

(c) Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the contract arises from causes beyond the control and without the fault or negligence of the Contractor. Examples of such causes include (1) acts of God or of the public enemy, (2) acts of the State in either its sovereign or contractual capacity, (3) fires, (4) floods, (5) epidemics, (6) quarantine restrictions, (7) strikes, (8) freight embargoes, and (9) unusually severe weather. In each instance the failure to perform must be beyond the control and without the fault or negligence of the Contractor.

(d) If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is beyond the control of both the Contractor and subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted supplies or services were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule.

(e) If this contract is terminated for default, the State may require the Contractor to transfer title and deliver to the State, as directed by the Procurement Officer, any (1) completed supplies, and (2) partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (collectively referred to as "manufacturing materials" in this clause) that the Contractor has specifically produced or acquired for the terminated portion of this contract. Upon direction of the Procurement Officer, the Contractor shall also protect and preserve property in its possession in which the State has an interest.

(f) The State shall pay contract price for completed supplies delivered and accepted. The Contractor and Procurement Officer shall agree on the amount of payment for manufacturing materials delivered and accepted and for the protection and preservation of the property; if the parties fail to agree, the Procurement Officer shall set an amount subject to the Contractor's rights under the Disputes clause. Failure to agree will be a dispute under the Disputes clause. The State may withhold from these amounts any sum the Procurement Officer determines to be necessary to protect the State against loss because of outstanding liens or claims of former lien holders.

(g) If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of the State, be the same as if the termination had been issued for the convenience of the State. If, in the foregoing circumstances, this contract does not contain a clause providing for termination for convenience of the State, the contract shall be adjusted to compensate for such termination and the contract modified accordingly subject to the contractor's rights under the Disputes

clause.

(h) The rights and remedies of the State in this clause are in addition to any other rights and remedies provided by law or under this contract. [07-7B075-1]

ESTIMATED QUANTITY -- PURCHASES FROM OTHER SOURCES (JAN 2006)

ILLEGAL IMMIGRATION (NOV 2008)

INDEMNIFICATION-INTELLECTUAL PROPERTY (JAN 2006)

(a) Without limitation and notwithstanding any provision in this agreement, Contractor shall, upon receipt of notification, defend and indemnify the State, its instrumentalities, agencies, departments, boards, political subdivisions and all their respective officers, agents and employees against all actions, proceedings or claims of any nature (and all damages, settlement payments, attorneys' fees (including inside counsel), costs, expenses, losses or liabilities attributable thereto) by any third party asserting or involving an IP right related to an acquired item. State shall allow Contractor to defend such claim so long as the defense is diligently and capably prosecuted. State shall allow Contractor to settle such claim so long as (i) all settlement payments are made by Contractor, and (ii) the settlement imposes no non-monetary obligation upon State. State shall reasonably cooperate with Contractor's defense of such claim. (b) In the event an injunction or order shall be obtained against State's use of any acquired item, or if in Contractor's opinion, the acquired item is likely to become the subject of a claim of infringement or violation of an IP right, Contractor shall, without in any way limiting the foregoing, and at its expense, either: (1) procure for State the right to continue to use, or have used, the acquired item, or (2) replace or modify the acquired item so that it becomes non-infringing but only if the modification or replacement does not adversely affect the specifications for the acquired item or its use by State. If neither (1) nor (2), above, is practical, State may require that Contractor remove the acquired item from State, refund to State any charges paid by State therefor, and take all steps necessary to have State released from any further liability. (c) Contractor's obligations under this paragraph do not apply to a claim to the extent (i) that the claim is caused by Contractor's compliance with specifications furnished by the State unless Contractor knew its compliance with the State's specifications would infringe an IP right, or (ii) that the claim is caused by Contractor's compliance with specifications furnished by the State if the State knowingly relied on a third party's IP right to develop the specifications provided to Contractor and failed to identify such product to Contractor. (d) As used in this paragraph, these terms are defined as follows: "IP right(s)" means a patent, copyright, trademark, trade secret, or any other proprietary right. "Acquired item(s)" means the rights, goods, or services furnished under this agreement. "Specification(s)" means a detailed, exact statement of particulars such as a statement prescribing materials, dimensions, and quality of wo(e) Contractor's obligations under this clause shall survive the termination, cancellation, rejection, or expiration of this Agreement. LICENSES AND PERMITS (JAN 2006)

During the term of the contract, the Contractor shall be responsible for obtaining, and maintaining in good standing, all licenses (including professional licenses, if any), permits, inspections and related fees for each or any such licenses, permits and /or inspections required by the State, county, city or other government entity or unit to accomplish the work specified in this solicitation and the contract. MATERIAL AND WORKMANSHIP (JAN 2006)

Unless otherwise specifically provided in this contract, all equipment, material, and articles incorporated in the work covered by this contract are to be new and of the most suitable grade for the purpose intended. [07-7B120-1]

PRICE ADJUSTMENTS (JAN 2006)

(1) Method of Adjustment. Any adjustment in the contract price made pursuant to a clause in this contract shall be consistent with this Contract and shall be arrived at through whichever one of the following ways is the most valid approximation of the actual cost to the Contractor (including profit, if otherwise allowed):

(a) by agreement on a fixed price adjustment before commencement of the pertinent performance or as soon thereafter as practicable;

(b) by unit prices specified in the Contract or subsequently agreed upon;

(c) by the costs attributable to the event or situation covered by the relevant clause, including profit if otherwise allowed, all as specified in the Contract; or subsequently agreed upon;

(d) in such other manner as the parties may mutually agree; or,

(e) in the absence of agreement by the parties, through a unilateral initial written determination by the Procurement Officer of the costs attributable to the event or situation covered by the clause, including profit if otherwise allowed, all as computed by the Procurement Officer in accordance with generally accepted accounting principles, subject to the provisions of Title 11, Chapter 35, Article 17 of the S.C. Code of Laws.

(2) Submission of Price or Cost Data. Upon request of the Procurement Officer, the contractor shall provide reasonably available factual information to substantiate that the price or cost offered, for any price adjustments is reasonable, consistent with the provisions of Section 11-35-1830.

PRICE ADJUSTMENT - LIMITED -- AFTER INITIAL TERM ONLY (JAN 2006)
