# DIGEST

The Chief Procurement Officer (CPO) grants South Carolina State University's (SCSU) request to cancel award where record clearly shows that the award was the result of administrative error. SCSU's request is attached as Exhibit A.

# AUTHORITY

The Chief Procurement Officer (CPO) conducted an administrative review pursuant to S.C. Code Ann. §11-35-1520(7) and Regulation 19-445.2085C. This decision is based on materials in the procurement file and applicable law and precedents.

# BACKGROUND

The facts pertinent to this decision are:

- On February 11, 2025, SCSU issued a solicitation seeking offers to provide indefinite delivery of construction services per Section 11-35-3320 governing task order contracting. [Exhibit B]
- The solicitation required offerors to have a South Carolina General Contractors-Building License (BD). [Id.].
- By the deadline for receipt of offers, SCSU received ten offers including one from Osmium Development Group, LLC (Osmium).

- On March 10, 2025, SCSU posted a notice of intent to award four task order contracts, including one to Osmium. [Exhibit C]
- Osmium has a South Carolina General Contractors-Specialty License with a Nonstructural Renovation subclassification (NR). [Exhibit D] Osmium lacks a BD license.
- On March 10, 2025, SCSU asked the CPO to cancel the award to Osmium.

# DISCUSSION

South Carolina Code of Laws Section 11-35-3320 allows the State to solicit construction services by contractor license classification or subclassification for unspecified quantities of services. Per this section, SCSU solicited construction services by the BD classification. No other license classification or subclassification was specified. Chapter 11, Title 40 of the South Carolina Code of Laws sets forth the work of each construction contractor license classification or subclassification. Section 40-11-410(1) specifies the work that may be performed by a contractor with a BD license. This work includes the work of other license subclassifications set forth in Section 40-11-410, including the work under an NR license. However, no other license classification or subclassification includes all of the BD classification. An NR licensed contractor may perform some of the work of a BD licensed contractor but not all. See S.C. Code Ann. § 40-11-410(4)(c).

The State may only award a contract to a responsible offeror. S.C. Code Ann. § 11-35-1810 and Reg. 19-445.2125. A responsible offeror is one who has the ability "in all respect to perform fully the contract requirements." S.C. Code Ann. § 11-35-1410(8). Ability includes being legally qualified. Reg. 19-445.2125A(4). Because Osmium only has an NR license, it is not legally able to perform all the work that may be required under a task order contract for BD contractor services. Therefore, Osmium is a nonresponsible offeror for the services of this solicitation, and it was administrative error for SCSU to award Osmium a contract.

#### Section 11-35-1520(7) states:

Correction or Withdrawal of Bids; **Cancellation of Awards**. Correction or withdrawal of inadvertently erroneous bids before or after award, or **cancellation** and re-award **of awards or contracts**, **after award but before performance, may be permitted in accordance with regulations promulgated by the board**. After bid opening, changes in bid prices or other provisions of bids prejudicial to the interest of the State or fair competition must not be permitted. After opening, bids must not be corrected or withdrawn except in accordance with the provisions of this code and the regulations promulgated pursuant to it. Except as otherwise provided by regulation, **all decisions** to permit the correction or withdrawal of bids, or to **cancel awards or contracts**, **after award but before performance**, **must be supported by a written determination of appropriateness made by the chief procurement officers or head of a purchasing agency**. [emphasis supplied]

Pursuant to this statute, the state adopted Regulation 19-445.2085, which states in relevant part:

C. Cancellation Of Award Prior To Performance.

After an award or notification of intent to award, whichever is earlier, has been issued but before performance has begun, the award or contract may be canceled and either re-awarded or a new solicitation issued or the existing solicitation canceled, **if the Chief Procurement Officer determines** in writing that:

(1) Inadequate or ambiguous specifications were cited in the invitation;

- (2) Specifications have been revised;
- (3) The supplies, services, information technology, or construction being procured are no longer required;
- (4) The invitation did not provide for consideration of all factors of cost to the State, such as cost of transporting state furnished property to bidders' plants;
- (5) Bids received indicate that the needs of the State can be satisfied by a less expensive article differing from that on which the bids were invited;
- (6) The bids were not independently arrived at in open competition, were collusive, or were submitted in bad faith;
- (7) Administrative error of the purchasing agency discovered prior to performance, or

(8) For other reasons, cancellation is clearly in the best interest of the State. [emphasis supplied]

Due to the error of SCSU in awarding a contract to Osmium when Osmium was not legally able to perform all of the work that may be performed under a BD license, cancellation of the intended award of a contract to Osmium is warranted.

# DECISION

For the foregoing reason, the CPO cancels the intended award of a contract to Osmium and remands this matter back to SCSU to proceed in accordance with the Consolidated Procurement Code.

# STATEMENT OF RIGHT TO FURTHER ADMINISTRATIVE REVIEW

Protest Appeal Notice (Revised July 2024)

The South Carolina Procurement Code, in Section 11-35-4410, subsection (1)(b), states:

(1) Creation. There is hereby created the South Carolina Procurement Review Panel which shall be charged with the responsibility to review and determine de novo:
(b) requests for review of other *written determinations*, decisions, *policies, and procedures* arising from or concerning the procurement of supplies, services, information technology, or construction procured in accordance with the provisions of this code and the ensuing regulations; except that a matter which could have been brought before the chief procurement officers in a timely and appropriate manner pursuant to Sections 11-35-4210, 11-35-4220, or 11-35-4230, but was not, must not be the subject of review under this paragraph. Requests for review pursuant to this paragraph must be submitted to the Procurement Review Panel in writing, setting forth the grounds, within fifteen days of the date of the written determinations, decisions, policies, and procedures.

(Emphasis added.) See generally Protest of Three Rivers Solid Waste Authority by Chambers Development Co., Inc., Case Nos. 1996-4 & 1996-5, Protest of Charleston County School District, Case No. 1985-5, Charleston County School Dist. v. Leatherman, 295 S.C. 264, 368 S.E.2d 76 (Ct.App.1988).

[The Request for Filing Fee Waiver form is attached to this Decision.] If the filing fee is not waived, the party must pay the filing fee within fifteen days of the date of receipt of the order denying waiver of the filing fee. Requests for administrative review will not be accepted unless accompanied by the filing fee or a completed Request for Filing Fee Waiver form at the time of filing." PLEASE MAKE YOUR CHECK PAYABLE TO THE "SC PROCUREMENT REVIEW PANEL."

LEGAL REPRESENTATION: In order to prosecute an appeal before the Panel, business entities organized and registered as corporations, limited liability companies, and limited partnerships must be represented by a lawyer. Failure to obtain counsel will result in dismissal of your appeal. *Protest of Lighting Services*, Case No. 2002-10 (Proc. Rev. Panel Nov. 6, 2002) and *Protest of The Kardon Corporation*, Case No. 2002-13 (Proc. Rev. Panel Jan. 31, 2003); and *Protest of PC&C Enterprises, LLC*, Case No. 2012-1 (Proc. Rev. Panel April 2, 2012). However, individuals and those operating as an individual doing business under a trade name may proceed without counsel, if desired.
